Personal History: I serve as the Manager for Diversity & Community Outreach for the Global Alzheimer's Platform Foundation, a non-profit that partners with several players in the health research sector motivated to find an effective treatment/therapy for Alzheimer's Disease. In my capacity, I have enjoyed meeting with seniors in several communities across Florida, sharing information about dementia & Alzheimer's disease, the advancements & opportunities in clinical research on aging, and encouraging folks to become more interested in their brain health. A significant portion of that work is simply connecting with these communities. Prior to this role, I worked with Homeless Services Network of Central Florida, the agency responsible for coordinating the homeless response system within the region. One of my reasons for emigrating from Jamaica to Orange County was my grandmother. Her move from New Jersey to Florida appeared reasonable; based on the assumption that the place where folks lived after retirement would have a lot of resources available for their age group. However, the reality was a lot of red tape to gain access existed. My experience has taught me that when overseeing any system of care or provision of social services, it is normal for a disconnect to exist between the service providers and those to be served. I realized that we needed real conversations about 1) access to resources not being inhibited by discrimination, 2) the ease of navigating those systems and 3) ensuring the community understood how. Often times, these conversations concluded with a need for better communication. It is my hope that, by serving on the Commission on Aging Board, I will gain insight into Orange County Government's approach to making our county more friendly for the aging population. I look forward to hearing the perspectives of others on the board and hope that my perspective on matters will be considered. I also hope to use my professional platform to assist where needed.
