## **ACTION REQUESTED:**

Approval of Amendment No. 14, Contract Y7-824, Design Services Texas Avenue Widening Project (South of Oakridge Road to South of Holden Avenue), with Inwood Consulting Engineers, Inc., in the amount of \$181,546.15, for a revised total contract amount of \$1,640,454.74.

## PROCUREMENT:

This amendment provides for additional scope of services for Texas Avenue North post design and Texas Avenue South plans update, bid package preparation, and post design services. The contract will be extended by 730 days from the date the amendment is executed.

## **FUNDING:**

## **DISCUSSION:**

The following are the previous contract actions:

Original Contract: Date: 05-02-08

The scope includes final engineering design and construction plans preparation for the Texas Avenue (from South of Oakridge to South of Holden Avenue) widening project. Engineering design includes roadway design, drainage design, structural design, permitting, signalization design, landscaping, and maintenance of traffic. The Contract was authorized for award by the Board on December 18, 2007.
