Re: 30.421 Acre property, SW corner of Rouse Road and McCullough Road, Orange County, FL.

Mayor Jacobs:

The Seminole County Board of County Commissioners was approached by Mr. R. Wayne Harrod, President of the Harrod Group, Inc., regarding his current ownership of approximately 30 acres of land in Orange County contiguous to the Seminole County border. Mr. Harrod has provided material to our Board, County Manager and staff which documents the ecological, historical and cultural characteristics and significance of the property, including a portion of the Little Econlockhatchee River which runs through his property. As you know, the contiguous property in Seminole County is within our charter protected rural areas.

To our understanding, Mr. Harrod is currently attempting to sell his property so that it can maintained as a public passive park in perpetuity. Mr. Harrod has demonstrated the public benefits of this concept, and the Board of County Commissioners agrees that a park at this location would serve a material public benefit to the entire area.

Therefore, the Seminole County Board of County Commissioners supports Mr. Harrod and his efforts to convert his property to a public passive park.
