NOTICE TO CUSTOMERS

Pursuant to Section 367.081(4)(a), Florida Statutes, water and wastewater utilities are permitted to adjust the rates and charges to its customers without those customers bearing the additional expense of a public hearing. These adjustments in rates would depend on increases or decreases in noncontrollable expenses subject to inflationary pressures such as chemicals, and other general operation and maintenance costs.

On April 23, 2019, Pluris Wedgefield, LLC filed its notice of intention with the Florida Public Service Commission to increase water and wastewater rates in Orange County pursuant to this Statute. The filing is subject to review by the Commission Staff for accuracy and completeness. Water rates will increase by approximately 1.39% and wastewater rates by 1.50%. These rates should be reflected for service rendered on or after June 22, 2019.

Dear Governor Scott:

On December 5, 2012, a member of my staff attended a public hearing in the Wedgefield community of Orange County hosted by the Public Service Commission (PSC). The purpose of the meeting was to obtain customer comments and input as they related to a proposed water and wastewater utility rate increase sought by the utility provider, Pluris Wedgefield, Inc., under PSC Docket #120152 WS. Based on reports to me from my staff, the citizens are infuriated by the notion that this utility provider would seek a second rate increase in a matter of four years — all to pay for water which is, according to them, of extremely poor quality and undrinkable.

This raised several questions for me and I wanted to bring their concerns to your attention. Therefore, I am writing seeking your assistance on behalf of the approximately 7,500 Wedgefield residents I represent. Below, I have outlined issues raised during the PSC's public hearing by residents in the community:

- Pluris Wedgefield purchased the utility serving the community in November 2009.
- During testimony at the December 5th meeting, residents complained of poor water quality, poor customer service, an aged and improperly maintained infrastructure, as well as a host of other issues related to their water and the rates they pay.
- Since September 20th, they have experienced five water outages resulting in multiple boil water alerts.
- Wedgefield residents already pay some of the highest rates for water and wastewater services in the state. They testified that their average bills are in the neighborhood of \$150 per month.

- Costs for water are compounded by the fact that, according to citizens' testimonies, they do not feel safe drinking the water and must buy bottled water for most all of their daily water needs.
- There are myriad other complaints from the residents about Pluris Wedgefield.

After hearing from the residents, they are exasperated in feeling as though they are being held hostage by constantly escalating rates of this private utility company. They have sought the assistance of their elected officials to combat this latest effort and I am compelled to advocate on their behalf because they feel they are voiceless against the PSC and in their plight. The President of the homeowners association recently appeared before the Orange County Legislative Delegation seeking their intervention in this matter. Therefore, I would ask that you direct your staff to review this matter independent of what the PSC staff's investigation has pertained to. I am seeking your support for the Wedgefield residents and encourage your staff to contact them to learn more about this matter which would be necessary for your office to formulate a position on the matter.

On behalf of the Wedgefield residents, thank you for your assistance in this matter and I look forward to their opportunity to fairly and openly discuss this serious matter. If you have any additional questions on this issue, please do not hesitate to contact me.

On behalf of Mayor Jacobs, thank you for contacting her on behalf of your family and neighbors regarding this matter. I will be certain to share with her your concerns and I know she will appreciate hearing from you.

Unfortunately, there is not much, if anything at all, Orange County Government can do in this matter since, as you know, Pluris is a privately-owned utility and is answerable (to some degree) to the Public Service Commission (PSC). In light of that, Orange County Government does not have any authority over this entity. The only local authority would lie with the Orange County Health Department, which is an agency of the State, and that would be pertaining to monitoring the quality of the water. Again, as you know, the PSC has input in the rates Pluris charges its customers and is not answerable to Orange County nor are they required to obtain any approvals or submit to any monitoring by the county. So, I wish there was more we could do to assist your neighbors and you with this issue.

I know the Wedgefield community has been in constant contact with Commissioner Ted Edwards' office and vice versa on this matter. I will be certain to share your continued concerns with Mayor Jacobs so she is kept abreast of what issues are important to you.

Our community recently had some serious issues with water quality. In addition, our rates were raised once again, approved by the Public Service Commission. I moved into Wedgefield in 2005 and this appears to be an ongoing issue.

In 2008, the water utility was owned by Utilites, Inc. It was previously Wedgefield Utilities. In 2009, the PSC approved a rate hike of more than 50%. We had a community meetting and wrote letters, but to no avail. The rates still went up. That was an outrage. Shortly afterwards, Pluris became the owners of the utility. Around that

same time, there was news that members of the PSC were fired. That was no surprise,

Once again, history is repeating itself. Pluris still owns the utility. We had several recent boil water alerts and water outages within a matter of days. Eyewitness News reported this. There is a petition circulating the community.

I have compared our ridiculous rates to others in the area. We pay around 50% more than other area residents. As a community, we feel violated. All we want is clean water and reasonable rates that are competitive. Being a private company should not give them the right to charge whatever they feel like charging. The Public Service Commision does not act in our best interests.

I am asking the Mayor to please check into this situation and confirm the information above. We need a strong advocate. I voted for her because I thought she was a fair, reasonable person who still cares about doing what is right for her consitituents, even if it is not always the politically popular path.

I am a resident of the Wedgefield subdivision. Recently, our water company raised our rates by over 50%. The name of this company is Wedgefield Utilities, owned by Utilities, Inc. You may have seen us on Eyewitness News recently, as it was discovered that AIG apparently has some holdings in this utility.

I attended a meeting regarding this issue held at our golf club last year. The Florida Public Service Cmmission was present to hear our concerns. My perception at that meeting and from the contacts I had with parties involved was that it was a "done deal"aiready and the meeting was really a waste of time. I have no doubt that the more powerful lobbyists aiready had their own meeting with the decision-makers.

It is unfathomable to me how the Public Service Commission could allow such an unfair, unreasonable increase, especially at a time when the country is in economic turmoil. If you do your research, I am sure you will discover that we have the highest water rates in Orange Country. I have compared our rates to those of several friends and I know this to be true. I believe that most people would accept a reasonable increase of around 10%. But to raise these rates so high on a utility that is a necessity for survival displays a lack of conscience.

I did my best to make the community aware of the issue by passing out filers and advising my homeowner's association. I wrote a letter to the PSC with my concerns. I was advised that I could speak at a meeting in Taily or partcipate in a conference call. I was unable to take time away from work to do this. I remained in contact with the lawyer who allegedly was advocating for us, but it was quite obvious the outcome would not be promising.

Many of my neighbors are as concerned about this as I am. We do not understand how this could happen. I would also like to know why Orange County is not able to provide our water. There were several comments made at our meeting that were quite disturbing regarding the past history with this

CUSTOMER NOTICE

ISSUED: JANUARY 23, 2009

On May 30, 2008, Wedgefield Utilities, Inc. (the "Utility"), completed its application to the Florida Public Service Commission (the "Commission") for increased water service rates, in which it requested a permanent water service rate increased 38.66%.

By Proposed Agency Action Order No. PSC-08-0827-PAA-WS ("PAA Order"), issued December 22, 2008, the Commission approved a rate increase of 50.69%. In addition, the Commission approved revised miscellaneous service charges. These rates and charges were designed to allow the Utility the opportunity to recover its reasonable and prudent costs for providing service, and a reasonable rate of return on its investment in facilities necessary to provide such water service. The PAA Order was not protested within the protest period, and became final by Order No. PSC-09-0037-CO-WS, issued January 20, 2009.

The increased rates and charges are effective for service on or after January 28, 2009.
