As a resident and business owner of Orange County, I appreciate that the Board of County Commissioners is taking the time to consider improving financing for property owners in Orange County, particularly at this time of pandemic and the economic uncertainty resulting from that. We understand that you are granting the option of SELF as a tool for property owners in the County, and would ask that you consider residential (Property Assessed Clean Energy) PACE at the same time. Unlike SELF, approving PACE for the County will be at NO COST to the County. Across our State PACE has delivered over \$1 billion of sustainability and resiliency property improvements, the majority of them in the category of windstorm mitigation which will help the state and its communities fare much better in future storm events, and help return the property insurance market back to a more sustainable situation. In most cases, property owners can see annual property insurance premium savings of between 25 and 50%. The burden of storm impacts can also be reduced helping the Counties and Cities with the potential allocation of tax dollars on post storm debris clean-up and economic assistance programs. The reduction in energy usage from PACE financed projects is also important and contributes to a reduction in greenhouse gas emissions. Our neighboring counties including Osceola and Brevard have enabled PACE through multi-provider PACE resolutions making the unincorporated areas and other municipalities available for PACE. Several of the Cities within Orange County have also enabled PACE (Orlando, Apopka and Winter Park). This particularly has affected us as a small business and has been the main source of growth. We currently use PACE in Osceola County and the city of Orlando and it provides over 75% of the finance of our customers. Having PACE available in Orange county will be a great benefit for small business as well as for customers. The current situation has seen unsecured forms of financing for home improvements withdrawn from the market making PACE an even more important opportunity for local businesses and homeowners. Over 155 Cities and 33 Counties in the State have enabled PACE and over 34 states in the US have enable PACE. PACE was enabled in the State of FL through legislation back in 2010 c. Over \$1 Billion in property improvements across all PACE programs that enhance wind storm resiliency, improve energy efficiency and generate renewable energy d. PACE both (1) removes the upfront cost obstacle for critical resiliency retrofits (roofs, windows, HVAC systems, renewable energy systems, etc.) and (2) makes the financing repayment manageable and predictable from an annual cash flow perspective e. The program is turn-key and can be turned-on through a resolution and agreements with existing PACE Districts at NO COST or RISK to the County f. #### Dear Commisioners and Staff,

# Support and Approve residential Property Assessed Clean Energy (PACE) in Orange County.

At the Board of Commissioners meeting tomorrow the Board will consider approving a grant of \$50,000 to the Solar and Energy Loan Fund of St Lucie County (SELF). We applaud the Board for opening up opportunities for property owners to make resiliency and energy efficiency upgrades to their properties before the impending hurricane season particularly during this time of unprecedented pandemic and economic crisis.

We would ask that the Board of Commissioners also take this opportunity to approve residential Property Assessed Clean Energy (PACE) which is a proven tool for homeowners across the State.

PACE was enacted to assist the property owners to finance energy efficiency, renewable energy, and storm resiliency improvements to their properties. The stability of PACE stems from the repayment mechanism whereby property owners repay their financing along with their annual property tax payments. PACE financing with a property tax lien results in lower interest rates, longer terms and lower payments than other forms of financing for these types of important projects. Since inception more than \$1bn of private capital has been utilized in Florida to deliver sustainability and resiliency property improvements through PACE. The majority of these projects are resiliency and storm hardening improvements which could result in insurance premium savings to property owners of 25% to 50% annually. There are also resulting savings to the Counties and Cities in terms of post-storm debris clean-up and economic assistance programs. This is in addition to the sustainability goals achieved through energy efficiency and renewable energy improvements, and the benefits to the local economy through job creation.

#### Some key features of PACE financing and consumer protections include:

**PACE financing a voluntary, special assessment on the subject property.** The assessment may remain with the property in the event of a sale but this does not need to be the case. A seller may choose to pay off the assessment at the point of sale, as they would a Home Equity Loan (HELOC). A PACE assessment should not be a barrier to the sale of a property.

**Qualifying products** – only qualifying products in energy efficiency, renewable energy and storm or wind resiliency may be financed through PACE assessments

**Length of financing** – While the availability of long term financing is useful to many property owners, PACE financing terms are, by statute, tied to the useful life of the product. A property owner may not obtain financing for a project that goes beyond the expected life of the product. For example, wind resistant roofing and impact windows both have a lifespan of 20 years so financing may not go beyond that period, and a central air conditioning unit may not be financed for more than 15 years. Property owners can also always choose shorter terms for their financing.

**Contractor oversight** – PACE admnistrators conduct rigorous onboarding, training and monitoring of local contractors who are working in the local neighborhoods to achieve the property upgrades. These contractors need to be state licensed, bonded and insured. We conduct background checks and we also have the most frequent inpsection policy in the industry (new contractors, random sample of existing contractors and all projects over a certain dollar threshold).

**Clear PACE disclosures and welcome calls** – in addition to receiving written disclosures, our customers participate in a recorded phone call with our representatives to make sure that they understand all the terms of the financing agreement. We offer both English and Spanish services.

**Completion certificates and calls** – contractors will only be paid once the contractor and homeowner have both signed off on the 100% completion of the project, and the homeowner participates in a second recorded call to verbally confirm they are happy with the project installation. We may also inpect the project prior to funding. This is not the case with other forms of financing.

**Right to cancel** – all property owners have the right to cancel their financing three business days after signing.

**No reverse mortgages** – PACE Funding does not allow any PACE financing for homeowners with reverse mortgages.

#### **Demand for PACE in Orange County**

PACE Funding Group works with a number of contractors who are based in the County employing local craftsmen and support staff.

In the last ten months that PACE Funding has been operating in Florida we have already been able to help 14 home owners and their families with upgrades in the Cities of Orlando and Apopka.

This represents a variety of different upgrades with seven different local home improvement companies including installation of solar systems, roofing, HVAC, and duct work and insulation.

#### Involvement of local contractors and economic impact of PACE

PACE financing gives local home improvement companies a financial tool to assist their customers. It helps contractors keep their staff employed, which is particularly important to them in the current economic situation.

#### **PACE Funding Group**

PACE Funding Group is a leading residential PACE funding company with a stable funding source – backed by a 100 year old, regulated bank. Headquartered in California where we have been an approved PACE administrator since 2015, we have a growing staff based in Florida. Including myself as Chief Investment Officer, we now have 12 staff based throughout the State working with a growing network of local contractors.

Approved in multiple states we have financed more than 9,000 residential PACE projects, invested \$300 million in local communities, created 2,000 jobs, and have contributed to the reduction of 21,356 metric tons of greenhouse gases annually.

#### Support residential PACE in Orange County

The pandemic and its effects on the economy have caused other unsecured forms of financing to be withdrawn from the marketplace, leaving residents with fewer choices and opportunities for their important resiliency projects. Recent news indicates that the hurricane season may well come earlier than expected and at a time when residents of the County are struggling to deal with the effects of the current pandemic and resulting economic situation. PACE remains an important tool and we ask that you support this as a choice for your residents.
