Mayor Jerry Demings and Orange County Commissioners, agreed in early July in the midst of the Coronavirus pandemic, to give up to 5 million of taxpayer dollars to Universal Orlando for development of another theme park. This came after a deal 7 months ago to give Universal 125 million dollars, totaling 130 million taxpayers dollars. Universal is owned by the cable conglomerate, Comcast that made over 13 billion dollars in profit last year. However, we are funding the relocation of their wastewater pipe, new roads that will run through their private land and new theme parks being constructed. These theme parks will not be in effect for usage at full capacity due to the Coronavirus pandemic side effects in our communities. Side effects such as: The extremely high rate of unemployed Floridians, high rate of Floridians still not receiving their appropriate unemployment benefits, some since March 2020. The extremely high percentages of positive Coronavirus cases, and death rates, and mental health trauma. As we as our hospital's ICU and Med-Surg beds that are at capacity or nearing full capacity with no treatment or prevention plan in place. The very huge possibility of a massive eviction, foreclosure, and basic utility shut-off's that will soon occur. My question is: I would like to receive an answer from both Mayor Demings and the County Commissioners, that approved these plans, to explain to us in the community: Why did you all vote to give 130 Million to Universal Orlando/Comcast, especially the extra 5 million during the Coronavirus pandemic?

Regarding the CARES Small Business Grant, I am requesting an increase in the \$50k PPP cap currently in place to \$75k, as most businesses that are unable to apply that are operating in the Main Street Districts due to this restriction. This would be especially helpful to bars and breweries that are under a second closure per state mandate and have been ordered closed more days than allowed to be open in 2020. This grant would be a lifeline that would give us hope and allow us to keep our current employees on payroll. I feel that the cap on PPP punishes small businesses for growing and employing more staff. Ivanhoe Park Brewing Co. has been open 2 years now and with our growth in the community, we had created 15 jobs. With those jobs and salaries, we were able to secure \$72k in PPP, which helped for the 8 weeks starting back in March. We have retained most of our staff, but with the ongoing commercial lease, utilities, taxes, and other operational expenses, it won't be sustainable much longer. We feel like we have become a part of the community, offering Family Day every fourth Sunday of the month, charging nothing for use of the bounce house, face painting, balloon artist, and a Family DJ as a thank you to the community for their support. We have held events like Ivanhoe Park Brewing Day that was proclaimed by Orlando Mayor Buddy Dyer, with his own beer that he tapped on a firkin. To celebrate the next year, we had Congresswoman Murphy, County Commissioner Bonilla, and City Commissioner Stuart out with each having their own beer brewed for the event. I have dedicated a lot of my time to the City and District and hope my voice can be heard not just for my business, but all of the others that I am in communication with, being the president of the board for Ivanhoe Village Main Street. Having the brick and mortar location in the Main Street District has me paying a commercial lease and utilities on top of my personal mortgage and utilities. If we were unable to maintain our expenses, we would be losing


