There are many pro's & con's to allowing the Micromobility device industry (e-scooters) to operate within Orange County and the International Drive area.

Pros: Good way to commute short distances; E-scooters are relatively eco-friendly; Convenience of availability; Low cost to the end user to rent and you don't need a driver's license to operate one.

Cons: Public and private areas being cluttered with e-scooters that are dropped off anywhere & everywhere – not necessarily back to their origin point; visual clutter; High probability of negative encounters with pedestrians on sidewalks; No dedicated lane for them to operate in; Little to no training is involved; No control over who can use them (i.e.: children vs. adults) and the opportunity of accidents taking place due to the end user not being familiar with the product.

For the I-Drive Business Improvement District, the safety and well-being of our visitors & residents is of the utmost importance. We believe that the possibility of allowing e-scooters to operate within the County needs to be thoroughly researched and investigated before moving forward with an ordinance.

If an ordinance is enacted, which County department will be responsible for administering the ordinance along with being responsible for communicating and reporting issues to the e-scooter operators on a daily basis?

Should the County decide to proceed with moving forward on allowing e-scooters to operate within Orange County, we suggest that the County issue a RFP and select one or two companies to operate for the first year under a pilot program. After the first year, the program would be evaluated to determine if it should continue based on performance, incidents and accidents reported.
