I really think that Orange County should make it easier for concerned citizens to make a request for a traffic calming study. I see that the City of Orlando and Osceloa County have more practical procedures set in place to initially request a traffic calming study. Steps to request a traffic calming study with the city of Orlando are on this website https://www.orlando.gov/Initiatives/Vision-Zero/Steps-of-a-Traffic-Calming-Study#section-1 and steps to request a traffic study in Osceola County are listed on https://www.osceola.org/core/fileparse.php/7572/urlt/020320 Traffic-Calming-Application.pdf. In the city of Orlando and Osceola County one citizen has to initially report the problem for the process to began. In order for a Traffic Calming study to be completed in Orange County one Citizen or a Committee has to get 66% of Homeowners signatures just for a Traffic study to be initiated. The current procedures in Orange County make it very difficult for concerned citizens like myself to put in an initial request for a Traffic Calming study. Currently before a traffic calming study can began in a neighborhood we have to gather a petition from at least 66% of homeowners versus 1 citizen reporting the problem so a traffic study can be started. With the process Orange County has in place now neighborhoods are left for months to have to wait for a Traffic study to even get started. Only the Board of Orange county Commissioners can change the rules/ procedures set in place in order to improve our neighborhoods roadways.
