ACTION REQUESTED:

Approval to award Invitation for Bids Y21-1081-R2, Orange County Infrastructure Repair and Replacement, to the low responsive and responsible bidders, RMS Constructors Group, LLC, in the estimated contract award amount of \$4,114,100 for the base year and Condor Construction Corp., in the estimated contract award amount of \$4,023,750 for the base year. Further request authorization for the Procurement Division to exercise option years one and two for each contract.

PROCUREMENT:

Work under these contracts will consist of the removal and replacement of existing damaged infrastructure including sidewalks, curb, gutter, driveway approaches, and pedestrian ramps. The work may consist of the construction of new sidewalk in areas where there is no previous sidewalk or removal of asphalt and include adding or removing excess soil to accommodate installation of concrete to designated elevation. Work will be issued on an as-needed basis throughout Orange County.

FUNDING:

Funding is available in account number 1002-072-2906-3816.

APPROVALS:

The Roads and Drainage and Business Development Divisions concur with this recommendation.

REMARKS:

Seven bids were received in response to this Invitation for Bids and were evaluated for responsiveness, responsibility, and price reasonableness. The bids from Mercon Construction Company and C.A.P. Contracting, Inc. were deemed non-responsive for failure to achieve the M/WBE participation goal or provide sufficient good faith effort. Timely protests were filed by Condor Construction Corp., Schuller Contractors, Incorporated, and Stage Door II, Inc. Protests reviews were held by the Procurement Manager on October 14, 2021. The protests of Condor Construction Corp. and Stage Door II, Inc. were upheld and the protest of Schuller Contractors, Incorporated was denied. No appeals were received.

Multiple awards are necessary because the projected workload will exceed the capacity of a single contractor and are necessary to meet the requirements for multiple orders to be performed on an ongoing basis throughout the County. After achieving the minimum order requirements for each contract, the low cost contractor will be given the first opportunity to perform all work. The other contractor will be utilized in the event the low cost contractor is unable to perform within the required timeframe. RMS Constructors Group, LLC and Condor Construction Corp. have satisfactory records of performance for this type of work and have been determined to be responsible.

The Business Development Division evaluated the seven bids submitted for this project. The Business Development Division completed a M/WBE Availability Analysis. The scope of services for this project had M/WBE availability. As a result, the M/WBE goal is 24%. At the time of bid opening; at least 39 firms were certified to provide the scope of services at the subcontract level.

The apparent low bidder, submitted by RMS Constructors Group, LLC reported 25.12% in M/WBE participation and met the Orange County M/WBE participation goal of 24%. Please note the following certified M/WBE participation:

The apparent second low bidder, submitted by Condor Construction Corp. reported 25.18% in M/WBE participation. While they listed M/WBE Siles and Sons, German Delaware Inc., Flash-Rite, Inc., and Ortiz Concrete Inc in their bid; they did not specify their scopes of services on attachment C-2 and their M/WBE participation could not be confirmed. The bidder did not achieve good faith effort documentation.
