ACTION REQUESTED:

Approval to award Invitation for Bids Y21-7049-TA, Orange County Gravity Replacement Package 29, to the low responsive and responsible bidder, Ric-Man Construction Florida, Inc. in the total contract award amount of \$704,945.60.

PROCUREMENT:

Work under this contract includes installation of cured-in-place pipe lining for existing gravity sanitary sewers, lining existing manholes, and seal and coat existing manholes. This project is located in Districts 3 and 4.

FUNDING:

Funding is available in account number 4420-038-1500-051-6340.

APPROVALS:

The Utilities Engineering and Business Development Divisions concur with this recommendation.

REMARKS:

Six bids were received in response to this Invitation for Bids and were evaluated for responsiveness, responsibility, and price reasonableness. The bids from Benchmark Construction Co. Inc. and Miller Pipeline, LLC were deemed non-responsive by the Procurement Division, based on the analysis provided by the Business Development Division, which identified that the M/WBE participation goal was not achieved and sufficient good faith effort documentation was not provided. The bid from Granite Inliner, LLC was deemed non-conforming due to turning in a corrupt file that could not be opened and verified. References provided were satisfactory for this type of work and Ric-Man Construction Florida, Inc. has been determined to be responsible. Therefore, award is recommended to Ric-Man Construction Florida, Inc.

The Business Development Division evaluated five bids submitted for this project. The Business Development Division completed an M/WBE Availability Analysis. The scope of services for this project had limited Minority/Women Business Enterprise availability. As a result, the M/WBE goal was reduced to 11%. At the time of bid opening, at least 42 M/WBE firms were certified to provide the scope of services at the subcontract level.

The apparent low bidder, submitted by Benchmark Construction Co. Inc., reported 1% in M/WBE participation. They did not meet the 11% M/WBE participation goal and did not submit sufficient good faith effort documentation. Please note the following certified M/WBE participation:
