DISCUSSION:

On September 17, 2002, the Board authorized the selection of NV5, Inc. (formerly Lochrane Engineering, Inc.) and authorized negotiation and execution of a contract by the Procurement Division. The contract was executed on November 24, 2003 for a total contract amount of \$1,166,036.44.
