ACTION REQUESTED:

Approval to award Invitation for Bids Y22-1011-AV, Elevator, Escalator, and Moving Sidewalk Maintenance, to the sole responsive and responsible bidder KONE Inc., in the estimated contract award amount of \$19,507,500 for a five-year term. Further request authorization for the Procurement Division to renew the contract for two additional one-year terms.

PURPOSE:

This contract will provide inspection, testing, and as needed maintenance and repair services of the elevator, escalator and moving sidewalks within the Convention Center.

FUNDING:

Funding is available in account number 4430-035-0922-3810.

APPROVALS:

The Orange County Convention Center and Business Development Division concur with this recommendation.

REMARKS:

One bid was received in response to this Invitation for Bids and was evaluated for responsiveness, responsibility, and price reasonableness. Services covered by this contract include inspection, testing, and as-needed maintenance and repair services. KONE Inc. has the necessary manpower and equipment to perform this type of work. Staff has determined that bid prices are reasonable based on comparison to previous contract prices. KONE Inc. meets all specifications and requirements of the solicitation. Therefore, recommendation for award is made to KONE Inc.

To ensure an open and competitive bid process, the Invitation for Bids (IFB) was posted on the County's e-procurement solution. A query from staff to potential bidders that declined to compete on this project resulted in the following:

- Skyline Elevators: Could not respond because the IFB contains escalators, and their insurance would not allow it.
- Thyssen Krupp Elevator: Did not respond to the query.
- Schindler Elevator Corporation: Did not respond to the query.
