## ACTION REQUESTED:

Approval to award Invitation for Bids Y22-7004-ZR, Parks Taborfield Neighborhood Park, to the low responsive and responsible bidder, CIC Construction Group USA, LLC in the total contract award amount of \$1,433,122.

### PROCUREMENT:

Work under this contract includes the development of a new neighborhood park in Horizon West, including earthwork, site hardscape improvements consisting of sidewalk park furniture, pavilion, playground, exercise equipment, and provisions for landscape and irrigation. The project is located in District 1.

#### FUNDING:

Funding is available in account number 1050-062-2158-6310.

## APPROVALS:

The Capital Projects Division and Business Development Division concur with this recommendation.

## REMARKS:

Six bids were received in response to the Invitation for Bids and were evaluated for responsiveness, responsibility, and price reasonableness. The bid submitted by S.A. Casey Construction, Inc. was deemed non-responsible for failure to meet the similar project criteria. The bid submitted by American Persian Engineering and Construction, LLC dba APEC, LLC was deemed non-responsive for not providing the required bid bond. The bid submitted by Phoenix Canopy and Shades LLC was deemed non-responsive for not providing the required bid forms and solicitation documents. The low bid is considered reasonable based on cost estimate range and current market. References

provided were satisfactory for this type of work and CIC Construction Group USA, LLC has been determined to be responsible. Therefore, award is recommended to CIC Construction Group USA, LLC.

The Business Development Division evaluated all four bids submitted for this project. The scope of services for this project had Minority/Women Business Enterprise availability. As a result, the M/WBE goal is 25%. At the time of bid opening, at least 70 M/WBE firms were certified to provide the scope of services at the subcontract level.

The apparent low bidder, submitted by CIC Construction Group USA, LLC, reported 30% in M/WBE participation in their bid. The M/WBE goal was met. Letters of intent were received from the low bidder for the M/WBE subcontractor listed. Please note the following certified M/WBE participation:
