### ACTION REQUESTED:

Approval to award Invitation for Bids Y22-7014-TA, Pine Hills Pedestrian Safety Improvements Phase 1, to the low responsive and responsible bidder, RMS Constructors Group, LLC, in the estimated contract award amount of \$5,372,082.

#### PROCUREMENT:

This project will improve pedestrian safety by constructing a raised median along Pine Hills Road and a 10-foot sidewalk along the east side of the roadway as well as upgrading curb ramps. The project includes signalization, knee wall and sign structures, wayfinding signs, adjustment of curb, pattern pavement and architectural pavers at the intersection of Pine Hills Road and Silver Star Road. The project is located in Districts 2 and 6.

## **FUNDING:**

Funding is available in account number 1002-072-5137-6311.

#### REMARKS:

Two bids were received in response to this Invitation for Bids and were evaluated for responsiveness, responsibility, and price reasonableness. The bid from Cathcart Construction Company-Florida, LLC was deemed non-responsive by the Procurement Division based on the analysis provided by the Business Development Division which identified that the M/WBE participation goal was not achieved and sufficient good faith effort documentation was not provided.

Staff determined that the bid from RMS Constructors Group, LLC is considered reasonable for this type of work. References provided by RMS Constructors Group, LLC were verified and deemed satisfactory for this type of work.

The Business Development Division evaluated the two bids received for this project. The Business Development Division completed an M/WBE Availability Analysis. The scope of services for this project had Minority/Women Business Enterprise availability. As a result, the M/WBE goal remained at 25%. At the time of bid opening, at least 36 M/WBE firms were certified to provide the scope of services at the subcontract level.

The apparent low bid, submitted by RMS Constructors Group, LLC, reported 26.81% in M/WBE participation. While they listed M/WBE firms in their bid they did not specify the scope of classification on attachment C-2. Letters of intent were received from the low bidder for the M/WBE subcontractors listed which confirmed the scope of classification and the scope of services listed on attachment C-2. Please note the following certified M/WBE participation:

The apparent second low bid, submitted by Cathcart Construction Company-Florida LLC, reported 25.01% in M/WBE participation. While they listed M/WBE firms in their bid, they did not specify the scope of classification. In addition, two of the firms listed we could not verify the certification. Thus, they did not meet the 25% M/WBE participation goal and did not achieve good faith effort. Please note the following certified M/WBE participation that is not confirmed:
