WHEREAS, pursuant to procedures adopted by the Board of County Commissioners, a petition was filed with the Board to vacate those certain **two utility easements one 10 feet wide by 100 feet long and another 5 feet wide by 105 feet long** in Orange County, Florida, as described in attachment.

WHEREAS, notice of a public hearing before the Board of County Commissioners on **August 30, 2022**, was published in the *Orlando Sentinel*, a newspaper of general circulation in Orange County, Florida, one time at least two weeks prior to the date for the hearing; and

WHEREAS, the Board finds that the vacating of the **two utility easements one 10 feet wide by 100 feet long and another 5 feet wide by 105 feet long** will not operate to the detriment of Orange County or the public.

The county road, right-of-way, easement, or park described above is vacated as of this date and Orange County renounces any rights in it.

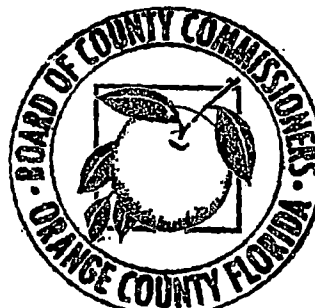
