Consideration: AN ORDINANCE AMENDING THE ORANGE COUNTY PARKS AND RECREATION IMPACT FEE ORDINANCE CODIFIED AT ARTICLE VI, CHAPTER 23, OF THE ORANGE COUNTY CODE; PROVIDING FOR UPDATED PARKS AND RECREATION IMPACT FEES, INCLUDING INCREASED PARKS AND RECREATION IMPACT FEES IN ALL LAND USE CATEGORIES; PROVIDING AN EFFECTIVE DATE AND DIRECTING THE CLERK OF THE BOARD TO PUBLISH A TIMELY NOTICE STATING THAT THE BOARD HAS ADOPTED THIS ORDINANCE IMPOSING INCREASED PARKS AND RECREATION IMPACT FEES, WITH ANNUAL INDEXING.
