## Equipment:

L3 Harris NGAL Infrared Illuminator and Designators - \$32,500. The Orange County Sheriff's Office SWAT Team was previously awarded approval to purchase 50 L3 Harris NGAL infrared illuminator devices at the cost of \$130,000. Since the time of submission and Board approval on September 27, 2022, L3 Harris increased the price by \$32,500.
