On March 8, 2022, the Board accepted an award from the U.S. Department of Health and Human Services, for the HIV Emergency Relief Project Grant in the amount of \$11,121,097. The U.S. Department of Health and Human Services approved carry over dollars from FY 2021 in the amount of \$1,483,660. In addition, the grant previously budgeted an estimated program income amount of \$50,000. This brings the total current grant budget to \$12,654,757, which represents an increase of \$1,483,660. The budget period for this award is March 1, 2022, through February 28, 2023.

The Ryan White Part A Program provides health and support services for people with the human immunodeficiency virus (HIV) living in Orange, Osceola, Seminole, and Lake counties. Funding is utilized for core and support services consisting of medical and dental care, nutritional supplements, insurance co-pay and premium payments, medical case management, pharmaceutical drug reimbursement, mental health counseling, and substance abuse treatment. Food, transportation, and psychosocial support services complement the program as support components.

Therefore, in accordance with Section 129.06(2)(d), Florida Statutes, it is recommended that the following accounts be adjusted by the amounts shown.
