ACTION REQUESTED:

Approval to award Invitation for Bids Y22-1053-MV, Fire Rescue Hazmat Supplies and Equipment, to the low responsive and responsible bidders by lots: Emergency Vehicle Repair, Inc. for lot 6, in the estimated amount of \$265,000; Fisher Scientific Company, L.L.C. for lots 3, 5, 12, 15, 19, 26, 36, 37, 46, 50, 57, 58, 59, 60 and 64 in the estimated amount of \$3,203,420; JCO Corporation for lot 67, in the estimated amount of \$49,600; Municipal Emergency Services, Inc. for lots 10, 17, 30, 34, 39, 44, 45, 54, 55 and 65 in the estimated amount of \$2,111,900; Municipal Equipment Company, LLC for lots 4, 23, 23, 25, 28, 41 and 48, in the estimated amount of \$912,930; TechnicalRescue.com, Inc. for lots 1, 14, 24, 35 and 49 in the estimated amount of \$442,500; Ten-8 Fire & Safety, LLC for lots 2, 11, 13, 20, 21, 22, 27, 38, 56, 62 and 63 in the estimated amount of \$2,549,590 and Trail Saw & Mower Service, Inc. for lot 61 in the estimated amount of \$135,200. The total overall estimated contract award amount is \$9,670,140 for the initial one-year term. Further request Board authorization for the Procurement Division to renew the contracts for four additional one-year terms. in the estimated amount of \$135,200.

PROCUREMENT:

Fire Rescue/Hazmat supplies and equipment are used at County fire stations and include, but are not limited to, fire hose, nozzles, bunker gear, helmets, self-contained breathing apparatus, full body hazmat suits and gloves.

APPROVALS:

The Fire Rescue Department and the Business Development Division concur with this recommendation.

REMARKS:

Eleven bids were received in response to this Invitation for Bids (IFB) and were evaluated for responsiveness, responsibility, and the percentage discount from the most recently published manufacturer's price lists.

North America Fire Equipment Co., Inc. was deemed non-responsive for all lots for adding terms. Team Equipment, Inc. was deemed non-responsive to all lots for failing to submit the minimum references required per the IFB. Fisher Scientific Company, L.L.C. was deemed non-responsive for Lots 7, 30, and 42 for adding terms and for lot 31 for not completing all lines within the lot. Municipal Emergency Services, Inc. was deemed non-responsive for Lot 2 for failing to submit the required manufacturer's letter, Lots 31 and 42 for failing to complete all lines within the lot, and Lot 63 for adding terms. The bids received by Fisher Scientific Company, LLC., Municipal Equipment Company, LLC. and Ten-8 Fire & Safety, LLC. were corrected due to math errors. Lots 17 and 19 required a tie breaker in accordance with the Procurement Procedures Manual Section 6. As a result, award is recommended to award Lot 17 to Municipal Emergency Services, Inc. based on closeness to delivery point or work site and to award Lot 19 to Fisher Scientific Company, L.L.C. based on previous vendor records on similar projects or requirements.

Thirteen lots will not be awarded because no bids were received for those lots.
