Florida Photonics Cluster Amendment to the FY 2022 Grant Agreement Extension

On May 1, 2022, the Board approved funding a grant agreement with Florida Photonics Cluster from October 1, 2021, through September 30, 2022. The grant will create a video aimed at showing secondary and early career students optics and photonics technology. In addition, students will be recruited in underrepresented demographics to participate in this initiative.

Due to the impacts of COVID19, an extension of the grant agreement is requested through September 30, 2023. The amendments to the agreement have been reviewed by the County Attorney's Office.

**AMENDMENT TO FY 2022
GRANT AGREEMENT**

THIS AMENDMENT TO FY 2022 GRANT AGREEMENT ("Amendment"), is made and entered into this 1 day of January 2023, by and between ORANGE COUNTY, FLORIDA, a charter county and political subdivision of the State of Florida ("County"), and Florida Photonics Cluster, Inc., a Florida non-profit corporation ("FPC").

WITNESSETH:

WHEREAS, the County and FPC entered to that FY 2022 Grant Agreement dated May 1, 2022 ("Agreement"), pursuant to the terms and conditions of which the County provides grant funds to FPC for the operationsof the FPC; and

WHEREAS, the County and FPC desire to amend the Agreement to extend its term in order to provide FPC additional time to expend the grant funds for the purposes authorized by the Agreement.

NOW THEREFORE, in consideration of the premises and mutual covenants herein contained, the Agreement is hereby amended as follows:

Section 1. Term of the Agreement. The term of the Agreement is hereby extended and shall terminate on September 30, 2023, and FPC shall have until then to spend or encumber the County Contribution.

Section 2. Revision to Exhibit "B." The due date for the final performance and financial report referenced in Exhibit "B" to the Agreement shall be extended to September 30, 2023.

Section 3. Retroactive Effective Date. This Amendment shall be retroactively effective as of January 1, 2023 with the same force and effect as if this Amendment had been executed on that date.
