RECOMMENDATION:

Selection of one firm and two ranked alternates to provide Design Services for Orange County Convention Center North-South Building Food Service Renovations, Request for Proposals Y24-807-MB from the following firms listed alphabetically:

- Architectural Design Collaborative, Inc.
- Helman Hurley Charvat Peacock/Architects, Inc.
- KZF Design LLC d.b.a KMF Architects

Request Board authorization for the Procurement Division to negotiate and execute a contract with a not-to-exceed budget of \$1,759,831. Further request authorization for the Procurement Division to formally terminate negotiations with the top ranked firm, if we are unable to come to a favorable negotiated agreement, and commence negotiations with the next ranked alternate until a successful negotiation is reached.

The proposals were evaluated by the Procurement Committee on February 7, 2024. Commissioner Nicole Wilson was assigned to the Procurement Committee.

PROCUREMENT:

This contract will provide architectural and engineering design as well as construction to renovate the food courts and restaurants interior finishes such as flooring, ceiling, walls, and seating. In addition to renovating the food courts and restaurants interior finishes, the scope includes upgrading plumbing, mechanical variable air volumes, electrical, energy efficient lighting, kitchen equipment and hoods, and hood controls, while protecting other existing building systems (i.e., fire protection and alarms, drain lines, A/C controls) already replaced to meet local and federal regulations. Additionally, as part of the design services, the functionality of existing systems described in the above paragraph must be reviewed and documented. The new design would provide equal or better systems. This project is located in District 6.
