CONSTITUTIONAL/CHARTER OFFICERS WORK GROUP REPORT

Work Group Chair Nix presented an update on the Constitutional/Charter Officers Work Group. The work group met on May 10, 2016, and decided on three (3) options:

- Take no action concerning the Constitutional Officers (labeled as Exhibit A in the June 9th Agenda packet or CCO Work Group's March 31, 2016 recommendation)
- Adopt a Charter amendment changing the Constitutional Officers to Charter Officers and providing for nonpartisan elections and term limits using ballot summary and charter language (labeled as Exhibit B in the June 9th Agenda packet and also as

General Counsel Vose's Memo dated April 19, 2016: Charter Amendment to address issues raised by plaintiffs).

- Adopt charter amendment with "springing" language made effective only if nonpartisan elections or term limits for constitutional officers are judicially invalidated for changing constitutional officers to charter officers and providing for nonpartisan elections and term limits, using ballot summary and charter language (labeled as Exhibit C in the June 9th Agenda packet).

General Counsel Vose provided additional information regarding the three options. General Counsel Vose also provided further understanding to the CRC of the Court's oral ruling from May 26th of *Demings vs Orange County* relating to nonpartisan elections and term limits for Constitutional Officers, the ballot summary and title of the Charter amendment and the Florida Election Code.

Discussion ensued amongst CRC members related to the Court's ruling. General Counsel Vose contributed to the discussion.

• REVIEW OF CRC FINAL REPORT

Chair Shaughnessy addressed the CRC regarding review of the draft of the CRC Final Report, which includes the first two (2) questions on the ballot. Another draft report will be provided to the CRC members on or about June 16, 2016. CRC members can contact CRC staff with any typographical errors or minor corrections to the Final Report. Chair Shaughnessy requested input from CRC members regarding any substantive corrections to the final report.

Mr. Mellen suggested the following change to the Final Report:

 Page 11, Question #1, under Introduction, last line: amend the Charter and adopt, amend or repeal ordinances.

Mr. Klein suggested a substantive change to the Final Report and the possibility of rescinding a prior action of the CRC regarding write-in candidates. General Counsel Vose discussed a request by Orange County Supervisor of Elections to remove Question #3 from the ballot regarding write-in candidates.

General Counsel Vose indicated that in order to take action on an item that was not specifically noticed in the agenda for a motion to rescind, it is subject to a two-thirds vote. Chair Shaughnessy explained the purpose of rescinding prior action of the CRC regarding write-in candidates.

Mr. DiVecchio discussed concerns from the public regarding language in the ballot title and proposal under Question #1. General Counsel Vose addressed the discussions from the Ballot Summary Work Group as requested by Chair Shaughnessy.

General Counsel Vose discussed the following changes to the Final Report as suggested by Orange County Supervisor of Elections Bill Cowles and his general counsel, Nicholas Shannin, regarding the Initiative Petitions Amendment primarily relating to the placement of financial impact statement. The following suggested revisions are as follows:

In Section 602 G.1. and Section 602., replace:

"The supervisor of elections shall place the comptroller's financial impact statement on the ballot immediately following the corresponding ballot summary."

with:

"The comptroller's financial impact statement shall be separately contained and placed on the ballot immediately following the correspondence ballot summary."

In Section 602 E.3., revise the second to last sentence as follows:

Upon receipt of the financial impact statement, the sponsor of the petition shall prepare and submit to the supervisor of elections for review and approval a revised petition form containing the financial impact statement, which statement shall be separately contained and placed immediately following the ballot summary.

General Counsel Vose also indicated a single word change requested by the County Attorney's Office to conform to current County usage for the following:

In Section 602 E.2., the word "purchasing" be replaced with the word "procurement".

In Section 602 E.2., the word "purchasing" be replaced with the word "procurement".

Chair Shaughnessy indicated that another draft of the Final Report will be issued with the changes from today's meeting including any typographical and punctuation changes. Chair Shaughnessy suggested that the changes appear in a redline version or highlighted in the Final Report.
