Commence at the Northwest corner of the South ½ of the West ½ of the Northwest ¼ of Section 25, Township 22 South, Range 30 East, Orange County, Florida, thence N 89°59'33" E a distance of 50.00 feet to the PC of a curve concave Southwesterly, having a radius of 450.000 feet, thence (Southeasterly) along the arc of said curve, through a central angle of 56°41′51", a distance of 445.30 feet to the PT of said curve, thence S 33°22′36" E a distance of 234.16 feet, thence S 89°59′33" W a distance of 697.52 feet to the Easterly right of way line of Chickasaw Trail, thence N 00°58′51" W a distance of 398.10 feet to the Point of Beginning.

#### Parcel 2:


