Approval to award Invitation for Bids Y16-1065-MG, Lot 1, Inmate Personal Care and Recreation Products, to the low responsive and responsible bidder, ICS Jail Supplies, Inc., in the estimated contract award amount of \$142,722 for a 3-year term contract. Further request authorization for the Procurement Division to renew the contract for two additional 1-year terms.

PROCUREMENT:

This contract will provide inmates with items to maintain daily personal hygiene and grooming.

FUNDING

Funding is available in account number 0001-081-3835-4115.

APPROVALS:

The Corrections Department and the Business Development Division concur with this recommendation.

REMARKS:

Four bids were received in response to the Invitation for Bids. The bids were evaluated for price, responsiveness and responsibility. Bob Barker Company and Phoenix Trading, Inc. dba Amercare Products Inc were determined to be nonresponsible for Lot 1 because the samples they provided failed to meet specifications listed in the bid. The bid submitted by Charm-Tex, Inc. was nonresponsive for failing to bid on all lines within the lot as required. The bid of ICS Jail Supplies, Inc. is the lowest responsive and responsible bidder. Therefore, award is recommended to ICS Jail Supplies, Inc. Lot 2 was awarded within the Procurement Division's authority.
