- **REMARKS:** Orange County obtained a Sidewalk Easement on July 9, 1995. By virtue of annexation on March 24, 2016, the easement is now located within the jurisdictional limits of the City of Winter Garden. The easement is no longer needed for County purposes and it is in the best interest of Orange County that its interest in the easement be assigned to the City of Winter Garden. The City of Winter Garden executed the Assignment of Easement on July 11, 2016, to assume all of the County's rights, duties, and obligations that exist under the terms and conditions of the easement.

ASSIGNMENT of EASEMENT

THIS ASSIGNMENT of EASEMENT, (hereinafter referred to as the "Assignment") is made by **ORANGE COUNTY**, a charter county and political subdivision of the state of Florida, whose address is P. O. Box 1393, Orlando, Florida 32802-1393, (hereinafter referred to as the "Assignor"), to and in favor of **CITY OF WINTER GARDEN**, a municipality duly enacted under the laws of the State of Florida, whose address is 300 West Plant Street, Winter Garden, Florida 34787, (hereinafter referred to as the "Assignee").

WHEREAS, Assignor is the owner of a Sidewalk Easement, filed July 9, 1985 and recorded in Official Records Book 3661, Page 2099, Public Records of Orange County, Florida; and

WHEREAS, by virtue of annexation, as outlined in Ordinance 16-22 and adopted on March 24, 2016, the easement is now located within the jurisdictional limits of the City of Winter Garden; and

WHEREAS, subject to the provisions herein, Assignor desires to assign, and Assignee desires to assume, all of Assignor's right, title, duties, obligations, and interest in the easement.

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereby agree as follows:

1. <u>Recitals</u>. The foregoing recitals are true and correct and are incorporated herein by reference.

2. <u>Assignment</u>. Assignor hereby assigns and transfers to Assignee, all of the Assignor's right, title, duties, obligations, and interest in the easement.

3. <u>Assumption</u>. Assignee hereby assumes from Assignor, all of Assignor's rights, duties, and obligations under the terms and conditions of the easement, including the maintenance of existing easement area and Assignee further agrees that, as a condition of this Assignment, Assignee shall assume and abide by all terms and conditions of the easement.
