RECOMMENDATION

Selection of one firm and a ranked alternate to provide Orange County Convention Center Arc Flash Analysis & Development of Electrical Safety Program Per National Fire Protection Association (NFPA 70E), Request for Proposals Y16-812-MM, from the following firms listed alphabetically:

RTM Engineering Consultants, LLC SGM Engineering, Inc.

Further recommend the Board authorize negotiation and execution of the final contract by the Procurement Division within a budget of \$400,000. Proposals were evaluated by the Procurement Committee on October 12, 2016. Commissioner Nelson was assigned to the Procurement Committee.

PURPOSE

To select a consultant to provide services for the Orange County Convention Center Arc Flash Analysis & Development of Electrical Safety Program Per National Fire Protection Association (NFPA 70E). The project is located in District 6.

DISCUSSION

The consultant will provide services to establish a comprehensive electrical safety program in accordance with the most current NFPA 70E and Standard for Electrical Safety in the Workplace, Institute of Electrical and Electronics Engineers, National Electric Code, National Safety Council and Occupational Safety and Health Administration standards at the Orange County Convention Center. The consultant will be responsible for outlining electrical hazards and risks for the OCCC campus. They will implement electrical safety & risk mitigation in conjunction with creating custom Standard Operating Procedures for routine electrical operations where applicable hazards and risks exist.

The consultant will create a comprehensive, stand-alone training manual and training program and implement through this program. The performance time for this contract extends from the initial Notice to Proceed for five years so that the required NFPA 70E Five Year Arc Flash re-assessment is included.

The tasks included in this scope of services can be generally grouped into the following six phases:

Phase 1: Preliminary Assessment and Recommended Project Plan Report Phase 2: Comprehensive Electrical Hazard & Risk Assessment Report Phase 3: Corrective Action Recommendation Plan Report Phase 4: Corrective Action Implementation and Related Implementation Phase 5: Post Corrective Action Review and Final Safety Certifications Phase 6: First Five Year Review, Document Updates and Certifications

Five proposals were received in response to the solicitation. The following firms scored too low for Board consideration: AVO Training Institute, Inc., Lewellyn Technology and Schneider Electric, Inc., USA
