WHEREAS, Orange County, Florida, as a result of Hurricane Matthew, is expected to encounter hurricane force winds, storms, rains and other potentially dangerous conditions; and

WHEREAS, such conditions constitute a clear and imminent threat to the lives and property of the people of Orange County; and

WHEREAS, the unincorporated and incorporated areas of Orange County, Florida, are threatened by Hurrican Matthew; and

WHEREAS, Chapter 252, Florida Statutes, and Chapter 2, Article IX, Orange County Code, empower the Orange County Mayor to declare a State of Local Emergency when conditions such as those described hereinabove are found to exist; and

WHEREAS, Chapter 252, Florida Statutes, and Chapter 2, Article IX, Orange County Code, empower the Director of Emergency Management to exercise extraordinary powers during the existence of a State of Local Emergency, including the exercise of certain powers by Emergency Orders issued by the Director of Emergency Management.

NOW, THEREFORE,

I, Teresa Jacobs, County Mayor of Orange County, Florida, do hereby find for the reasons set forth above that a State of Local Emergency exists within both unincorporated and incorporated Orange County, Florida.

Pursuant to pertinent legal authorities, I, Teresa Jacobs, by virtue of my office as County Mayor, shall act as Director of Emergency Management during the State of Local Emergency declared herein and am vested with all powers and authority granted to such position during the existence of the State of Local Emergency proclaimed hereby.

Furthermore, all procedures and formalities required by law of Orange County, Florida, as a political subdivision pertaining to the matters described in Section 252.38(3)(a)5.a. through h., Florida Statutes, are hereby waived during the State of Local Emergency.

As the Director of Emergency Management, I shall issue such other Emergency Orders as are required in order to conduct County business and to protect the health, welfare, and safety of the people and property within Orange County.

All public officials and employees of Orange County are hereby directed to exercise the utmost diligence in discharge of duties required of them for the duration of this State of Local Emergency and in the execution of State and Local emergency orders, regulations and directives.

All people of Orange County are called upon and directed to comply with all necessary emergency measures, and to cooperate with public officials and civil emergency/disaster service forces in executing emergency operational plans, and to obey and comply with the lawful direction of all properly identified public officers.

The State of Local Emergency declared hereby shall continue for seven days from the date and time hereof, and may be extended, as necessary, pursuant to Section 252.38(3)(a)5, Florida Statutes.

All pedestrian and vehicular movement, standing and parking, except for the provision of fire, police, emergency and hospital services, medical patients, utility emergency repairs and emergency calls by physicians within the above curfew areas, are prohibited during curfew hours. Curfew hours during which such movement is prohibited shall be from Friday, October 7, 12:01 A.M. until 7:00 A.M., Saturday, October 8, 2016.

Any and all persons abroad on the streets and sidewalks within any curfew area during the curfew period and not engaged in the provision of the above mentioned services shall be subject to arrest as provided in Section 901.15(1), Florida Statutes.

Section 2. Anyone who violates any prohibition, restriction or regulation made herein, unless language to the contrary appears herein, shall upon conviction be punished according to law and shall be subject to a fine not exceeding the sum of Five Hundred Dollars (\$500.00), or imprisonment in the County jail for a period not exceeding sixty (60) days, or by both such fine and imprisonment.

Section 3. Any variance or exception to the prohibitions and/or restrictions set forth in Section 1 shall be valid only when stated in a writing signed by me or under my authority.

Curfew hours during which such movement is prohibited shall be each day from Thursday, October 6, at 10:00 P.M. until 7:00 A.M., Saturday October 8, 2016.

Any and all persons abroad on the streets and sidewalks within any curfew area during the curfew period and not engaged in the provision of the above mentioned services shall be subject to arrest as provided in Section 901.15(1), Florida Statutes.

- **Section 2.** Anyone who violates any prohibition, restriction or regulation made herein, unless language to the contrary appears herein, shall upon conviction be punished according to law and shall be subject to a fine not exceeding the sum of Five Hundred Dollars (\$500.00), or imprisonment in the County jail for a period not exceeding sixty (60) days, or by both such fine and imprisonment.
