Report: Commissioner Boyd's District 1 office has requested the establishment of an MSBU for installation of a turn lane on Winter Garden Vineland Road into the Cypress Chase Unit 1 and Cypress Chase Unit 2 subdivisions. A total of **134** ballots were mailed to property owners to determine majority opinion. Approximately **76%** of the ballots returned were in favor of the establishment of the MSBU. The ballot detail is as follows:

<u>In favor of the MSBU</u>	41
<u>Not in favor of the MSBU</u>	13

The MSBU payment would be assessed with the annual property taxes for three (3) years. The current interest rate is 3.5%. The estimated capital cost of installing the turn lane is \$60,000 with Orange County providing funding in the amount of \$25,000 and the remaining funding in the amount of \$35,000 from the special assessments to the property owners. The total cost to the property owners is \$276.86. The annual assessment for this MSBU is \$101.32 per lot, per year which includes interest and administrative fees.

WHEREAS, Section 125.01 (l) (q), Florida Statutes, grants Orange County the power to establish Municipal Service Benefit Units (hereinafter known as "MSBU") for any part of the unincorporated areas of Orange County; and

WHEREAS, Section 197.3632, Florida Statutes, authorizes the levy, collection, and enforcement of the non-ad valorem special assessments in the same manner as ad valorem taxes; and

WHEREAS, the Board of County Commissioners of Orange County, Florida (hereinafter known as the "Board"), is the governing board of Orange County, Florida (hereinafter known as the "County") pursuant to its charter; and

WHEREAS, the County has received a request, in writing from Orange County District 1 Commissioner's Office for the establishment of such a MSBU to provide for the capital costs of installing a turn lane on Winter Garden Vineland Road by imposing special assessments against property benefited by the installation of a turn lane in that portion of the unincorporated area of Orange County to be known as Cypress Chase Unit 1 and Cypress Chase Unit 2 Replat MSBU and which is more fully described below; and

WHEREAS, the Board has, pursuant to notice duly given both by mail and by publication, held a hearing at which all interested persons who appeared were heard or given an opportunity to be heard as to (a) the desirability of undertaking the installation of the turn lane hereinafter described, (b) the desirability of defraying the cost thereof through non-ad valorem special assessments, (c) the amount by which each lot of real estate referred to in Exhibit "A" of this Resolution will be benefited by the installation of the turn lane, and (d) the amount to be assessed against each benefited property; and

WHEREAS, the Board has determined that the request of the property owners within the Cypress Chase Unit 1 and Cypress Chase Unit 2 Replat subdivisions, together with the other information pertaining to the installation, to be feasible, necessary to facilitate the services desired, and in the interest of the public health and safety, the installation of the turn lane on Winter Garden Vineland Road into the Cypress Chase Unit 1 and Cypress Chase Unit 2 Replat subdivisions described below should be made, and that the properties will be benefited, now and in the future, and that the MSBU should be created; and

THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF

RECORDING DEPARTMENT: RETURN TO FINANCE & ACCOUNTING SPECIAL ASSESSMENTS

ORANGE COUNTY, FLORIDA:

Section 1. Creation of MSBU.

There is hereby established and created the **Cypress Chase Unit 1 and Cypress Chase Unit 2 Replat 2017 Municipal Service Benefit Unit for installing a turn lane** subject to final adjustment and approval as provided for in Section 197.3632, Florida Statutes, the boundaries of which appear as the parcels on the tax map in Section 5, Township 24, Range 28, as listed in Exhibit "A" of this resolution, Public Records of Orange County, Florida. The purpose of this MSBU is to provide for collection and disbursement by Orange County of such funds as may be necessary to reimburse Orange County for expenditures made for installing a turn lane on Winter Garden Vineland Road into the Cypress Chase Unit 1 and Cypress Chase Unit 2 Replat subdivisions. It is understood and agreed that this MSBU is created solely for the purpose of payment to cover the costs associated with installing a turn lane on Winter Garden Vineland Road into the Cypress Chase Unit 1 and Cypress Chase Unit 2 Replat subdivisions.

Section 2. The Project.

(a) Nature of Improvement. A portion of the project shall be paid from special assessment proceeds for the costs of installing a turn lane on Winter Garden Vineland Road into the Cypress Chase Unit 1 and Cypress Chase Unit 2 Replat subdivisions.

(b) Location of Project. This turn lane will be installed on Winter Garden Vineland Road as an entrance into the Cypress Chase Unit 1 and Cypress Chase Unit 2 Replat subdivisions.

(c) Estimated Cost. The estimated capital cost of the improvements is **\$60,000 with Orange County providing funding in the amount of \$25,000.00 and the remaining funding in the amount of \$35,000.00 from the special assessments to the property owners.**

Section 3. Assessments.

(a) Portion of Capital Costs Paid by Special Assessments. A portion of the capital cost set forth in Section 2 (c) shall be paid from the proceeds of the non-ad valorem special assessments. The proceeds of the non-ad valorem special assessments will reimburse the County for cost paid out of the - **Orange County District 1 Public Works Fund and Local Option Gas Tax.**

(b) Manner of Assessment; Declaration of Benefit. All benefited property shall be assessed at the estimated rate of **\$101.32 per lot** for installing a turn lane on Winter Garden Vineland Road into the Cypress Chase Unit 1 and Cypress Chase Unit 2 subdivisions and the Board hereby declares that such method of non-ad valorem special assessment is proportionate to and not in excess of the special benefits to be derived by each benefited property from the installation of the turn lane.

(c) Annual Installments; Interest Fees. Special Assessments may be paid over a three- (3) year period in equal installments as provided in Section 17-344 of the Orange County Code. Said payments shall bear interest at the rate of 3.5% (three and a half percent) per annum as provided in Section 17-349 of the Orange County Code, plus an annual administration fee. The balance of the total cost of this MSBU may be paid in full at any time. This resolution shall be effective upon approval by the Board and the assessments shall start November 1, 2017 via the real estate tax bill.

(d) Collection of Annual Installments. It is the intent of Orange County that the Uniform Method for the levy, collection, and enforcement of non-ad valorem special assessments, as Section

197.3632 Florida Statutes grants, shall be used for collecting the non-ad valorem special assessments. One and one half dollars (\$1.50) for each lot of land shall be added by the Board to cover the costs of administering the MSBU and the total amount so determined shall be specifically assessed against the real property of the freeholders in the MSBU as provided hereafter. An additional amount will be added to provide for reimbursement of administrative costs incurred by the Property Appraiser and Tax Collector for the collection of non-ad valorem special assessments subject to the provisions of Section 197.3632, Florida Statutes.

Section 4. Assessed Lands; Individual Assessments. The specific properties benefited by the installation of the turn lane and the non-ad valorem special assessments imposed on each of them are shown in Exhibit "A" to this Resolution. In the event of division or splitting of any of the tax parcels or lots assessed herein, any such newly subdivided or split parcels shall be included in the MSBU non-ad valorem special assessments.

After adoption of the non-ad valorem special assessment roll by the Board, the Property Appraiser shall extend the non-ad valorem special assessment upon the non-ad valorem special assessment roll, which roll shall be fully completed prior to the time said Board sits as a Board of Tax Adjustment, during which time such non-ad valorem special assessment may be protested, reviewed, equalized and adjusted to conform to the provisions of Sections 197.3632 and 197.3635, Florida Statutes. After adjournment as a Board of Tax Adjustment, the Board of County Commissioners shall certify the non-ad valorem special assessment roll in the same manner and at the same time as the County Tax Roll is certified and delivered to the Tax Collector, and the non-ad valorem special assessments shall be collected in the same manner as and shall have the same priority rights, discounts for early payment, prepayment by installment method, deferred payment, penalty for delinquent payment, and issuance and sale of tax certificates and tax deeds for non-payment, and be subject to the same delinquent interest and penalties, and be treated in all respects the same as County ad valorem taxes. Said non-ad valorem special assessments, when collected by the Tax Collector shall be remitted to said Board, who shall deposit the same in such depository as shall be designated by the Board. From the proceeds of said non-ad valorem special assessments, the Board shall pay the costs of having a non-ad valorem special assessment roll made and extended. The Tax Collector's office shall receive all fees and costs of sale as provided by law for the collection of ad valorem taxes, advertising, sale of lands, and issuance and sale of certificates. The Uniform Method for the levy, collection, and enforcement of non-ad valorem special assessments, Section 197.3632, Florida Statutes, shall be used.

Section 5. Termination of MSBU.

Upon final payment of all non-ad valorem special assessments plus accrued interest, this MSBU shall automatically terminate.

Each property owner affected by this resolution has been provided first class mail notice of the potential for loss of his or her title when the Uniform Method of collection is used and that all affected property owners have a right to appear at the hearing and to file written objections with the Board. Each property owner affected by this resolution has been provided first class mail notice of the time and place of the public hearing at which this resolution was adopted. However, under Section 119.07, Florida Statutes, certain records may be noted as exempt and confidential. This public record exemption may cause certain property owners not to receive the above first class mail notice, however, a public hearing notice conforming to the provisions of Section 197.3632, Florida Statutes, has been published in a newspaper of general circulation within Orange County preceding the public hearing. The Board of County Commissioners shall be the governing board of said Municipal Service Benefit Unit.
