

RANGE 28 EAST, ORANGE COUNTY, FLORIDA, LYING WESTERLY OF THE WESTERLY RIGHT OF WAY OF APOPKA-VINELAND ROAD AS SHOWN IN ROAD PROJECT NO. 24D, 1926, PUBLIC RECORDS OF ORANGE COUNTY, FLORIDA, BEING MORE SPECIFICALLY DESCRIBED AS FOLLOWS:

BEGIN AT THE NORTHWEST CORNER OF THE NORTHWEST 1/4 OF SECTION 22, TOWNSHIP 24 SOUTH. RANGE 28 EAST, ORANGE COUNTY.
