November 2016 Neighborhood Pride Entranceway Grant

Recipients

The Neighborhood Preservation and Revitalization Division administers the Neighborhood Pride Grant Program that provides funds for citizen organizations to enhance the quality of their neighborhoods. The Neighborhood Pride Grants are available countywide in amounts ranging between \$1,500 to \$10,000. Neighborhood Pride Grant applications are accepted year-round and are reviewed monthly by the Neighborhood Grants Advisory Board (NGAB).

The NGAB is recommending the approval of six Entranceway Improvement Grants for Hidden Woods Community, Wedgewood Commons HOA, Ashbury Park HOA, Windsor Place HOA, Miller's Cove HOA and Country Chase I HOA. (see Attachment A). The grant requests are displayed in greater detail in Attachments B through G. The grant requests were reviewed and scored by Orange County staff and presented to the NGAB for recommendation. The applications were reviewed based on project feasibility, organizational readiness, and benefit to the community. In addition, the applications were reviewed against the County's permitting requirements to ensure that the project would comply with appropriate County codes. Finally, the organizations were required to document the appropriate cash match and demonstrate an ability to maintain the project.

Approval of November 2016 Neighborhood Pride Entranceway Grants as recommended by the Neighborhood Grants Advisory Board for Hidden (\$5,000); Wedgewood Woods Community Commons HOA (\$5,000); Ashbury Park HOA (\$5,000); Windsor Place HOA (\$3,000); Miller's Cove HOA (\$3,000) and Country Chase I HOA (\$5,000). 




