REMARKS: Orange County and the City of Orlando jointly own and manage the lands known as Conserv II, which were purchased under grant funding from the US Environmental Protection Agency (EPA) and as a result of the grant certain restrictive covenants were imposed upon the lands pursuant to the terms of a grant agreement between the parties. A portion of the land being released is leased to Parks and Recreation Division for the Sportsplex.

Orange County and the City of Orlando requested the EPA to release 31.33 acres of those lands needed for the construction of the Hamlin Groves Trail northern extension.






