TDT Application and Evaluation

Elements of proposed charter amendment

- BCC determine whether surplus TDT funds are available
- Protects bond obligations & contractual commitments
- Uses Evaluation criteria
- Quantitative scoring mechanism



- Establishes an additional priority (bucket) in the TDT Plan in an amount to be determined by BCC
- Annual determination during budgetary cycle whether excess unallocated TDT funds are available for grants
- BCC determines amount to be available for capital projects and events grants for which applicants may apply
- Applications accepted only in years that BCC determines funds are available – cash funding only
- Requires Application Review Committee (ARC) be established by BCC resolution



Application Review Committee (ARC)

- 11 member committee appointed by BCC
- 3 representatives recommended by TDC:
 - 2 representing owners/operators
 - 1 representing community arts organizations
- 8 representatives selected by BCC:
 - 1 recommended by each commissioner
 - 2 recommended by the mayor



ARC duties:

- Recommend allocation between capital & event grants
- Develop application cycle and procedures
- Review and rank applications
 - Form of applications to be adopted in Co. Admin. Regulations
- Utilize following criteria:
 - Commitment to expansion of tourism in County
 - Soundness of proposed event or project
 - Anticipated return on investment
- Make written recommendations to TDC and BCC

TDC makes recommendations to BCC

BCC receives recommendations from ARC and TDC and makes final decision
