ACTION REQUESTED:

Approval to award Invitation for Bids Y17-137-MG, Uniforms for Fire Rescue Department, to the low responsive and responsible bidder, Designlab, Inc. for an estimated contract amount of \$657,429.20 for a 1-year term. Further request authorization for the Procurement Division to renew the contract for four additional 1-year terms.

PROCUREMENT:

This contract will provide dress and daily uniforms for the Fire Rescue Department to wear.

FUNDING

Funding is available in account number 1009-034-0687-4175.

APPROVALS:

The Fire Rescue Department and Business Development Division concur with this recommendation.

REMARKS:

Two bids were received in response to the Invitation for Bids. The bids were evaluated for price, responsiveness and responsibility. Red the Uniform Tailor was deemed non-responsive because they submitted a partial bid and didn't complete the entire form on LOT 3. There is a 14% difference between the two bids. The low bid is considered reasonable compared to current contract pricing.
