RECOMMENDATION

Selection of one firm and an alternate to provide Design Services for Ecotourism Improvements at Magnolia Park, Request for Proposals Y17-800-CC, from the following firms listed alphabetically. Further recommend the Board authorize negotiation and execution of the final contract by the Procurement Division provided that it does not exceed the budget of \$400,000.

Proposals were evaluated by the Procurement Committee on December 14, 2016. Commissioner Jennifer Thompson was assigned to the Procurement Committee.

PURPOSE

To select a firm to provide design services for Ecotourism Improvements at Magnolia Park.

DISCUSSION

The project is for design services for ecotourism improvements at Magnolia Park, consisting of approximately 6 acres and may include improvements to existing amenities including a boat ramp, two restroom buildings, a group pavilion, and related access road and parking. New additions may also include the following amenities: new Eco-Center building, covered pavilion, fencing, concrete sidewalks, parking improvements, new dock system extending into Lake Apopka, fishing pier and overlook, additional docks for law enforcement, irrigation, drainage, and a trail head/connection to Lake Apopka trail.

The consultant will perform the following services:

- 2. Project Data/Information Gathering
- 3. Design Development
- 4. Construction Contract Documents
