This contract provides for all manpower, equipment and materials for the removal of existing sod in right of way medians and replace with new sod, trees and shrubs as designed by the County. This includes maintenance of the newly installed landscape for two years after installation.

REMARKS:

Three bids were received in response to this Invitation for Bids. The bids were evaluated for price, responsiveness and responsibility. Award is recommended to the low responsive and responsible bidder Ameriscapes Landscape Management Services, LLC for Lot B, Commission Districts 4, 5 and 6. Lot A was awarded under a prior solicitation Y16-1076 and approved by the Board on October 18, 2016. No responsive bids were received for Lot B under solicitation Y16-1076 therefore Lot B was re-bid under Y17-143-PD.

Staff has determined the price submitted is fair and reasonable, based on comparison to FDOT projects and current County contracts.
