Selection of one firm and four ranked alternates to provide Real Estate Representative Services under Request for Proposals, Y17-141-PD from the following firms, listed alphabetically. Further request Board authorization for the execution of a 3-year contract, renewable by the Procurement Division for two additional 1-year periods.

PURPOSE:

The firm will provide expertise in the local market to allow the County to make informed decisions without increasing our expenses for lease and acquisition transactions.

Contracted services will include preparation of cost comparison analysis, lease vs. own comparative analysis, the review of building and site plans, space planning, lease and acquisition negotiations, lease audits and written updates of costs in the operation and maintenance of various types of space for the County.

DISCUSSION:

The County currently leases warehouse and office space in excess of 690,002 square feet, from more than 30 different landlords at over 38 locations for an annual cost in excess of \$8,459,833. Each lease request from a division/department has its own distinct set of location and design specifications requiring specific market knowledge and expertise.

Due to the nature of these services, a contract amount cannot be established. However, under the current contract from 2011 to date, the County has received revenues of \$277,847 from new leases and the renewal of existing leases. The current contract will expire March 13, 2017.

Seven proposals were received in response to RFP Y17-141-PD and were evaluated by the Procurement Committee. As compensation for its services, the selected firm will receive a commission from the landlord/owner and will receive no compensation from the County. Also, when requested, the firm will seek to negotiate completion of additional tenant improvements to County leased facilities at the landlords/owners expense. The proposals from Amerivet Real Estate Services, Inc. and The Triece Company did not receive the minimum score to be considered for award.

Consensus scores from the Procurement Committee's evaluation are attached.
