SUBJECT: Award of Invitation for Bids Y17-123-MV, Automotive and  
Light Truck Parts

### ACTION REQUESTED:

Approval to award Invitation for Bids Y17-123-MV, Automotive and Light Truck Parts, to the low responsive and responsible bidders by lot in the estimated contract award amounts below, for an initial one year term.

Further request authorization for the Procurement Division to renew the contracts for four additional 1-year terms.

Due to projected usage, the Fleet Management Division anticipates that the entire estimated contract amount will be ordered during the initial contract term.

### PROCUREMENT:

To provide automotive and truck parts, as needed, for County owned vehicles.

### FUNDING:

Funds are available in account numbers 5530 043 2035 4163 and 4410 038 1025 3820.

APPROVALS:

The Fleet Management and Business Development Divisions concur with this recommendation.

REMARKS:

Eight bids were received in response to Invitation for Bids Y17-123-MV and evaluated for responsiveness, responsibility and price. Bidders provided a fixed percentage discount for sample items within each lot. Contract award is recommended, on a lot by lot basis, to the low responsive and responsible bidder.

Cold Air Distributors Warehouse of FL, Inc. was deemed non-responsive for lots 6 and 12 for failing to bid on all line items and failing to provide a fixed percentage. Genuine Parts Company was deemed non-responsive for lot 11 for failing to bid on all lines. Maudlin International Trucks provided no bid for lots 1-8 and 11 and was deemed non-responsive for lots 9, 12 and 13 for failing to provide a fixed percentage. O'Reilly Automotive Stores, Inc. was deemed non-responsive for modifying the terms and conditions of the Invitation for Bids.

The Fleet Management Division budgeted \$1,721,303.38 for all lots. This budget is based on the previous contract amount and usage. The funds are to be distributed amongst awarded bidders based on past usage of each item within each lot.


