WHEREAS, pursuant to procedures adopted by the Board of County Commissioners, a petition was filed with the Board to vacate those certain two portions of a 30 ft wide unopened and unimproved right-of-way known as Tot Circle, containing approximately 1,077 and 5,321 square feet respectively, for a total of 6,398 square feet in Orange County, Florida, as described in attachment.

WHEREAS, notice of a public hearing before the Board of County Commissioners on **February 21**, **2017**, was published in the *Orlando Sentinel*, a newspaper of general circulation in Orange County, Florida, one time at least two weeks prior to the date for the hearing; and


