## RESOLUTION GRANTING PETITION TO VACATE \# 15-12-025

WHEREAS, pursuant to procedures adopted by the Board of County Commissioners, a petition was filed with the Board to vacate that certain portion of a 60 ft wide unopened and unimproved right-of-way known as Reams Road, containing approximately 0.297 acres in Orange County, Florida, as described in attachment.

WHEREAS, notice of a public hearing before the Board of County Commissioners on February 21, 2017, was published in the Orlando Sentinel, a newspaper of general circulation in Orange County, Florida, one time at least two weeks prior to the date for the hearing; and

WHEREAS, the Board finds that the vacating of the portion of a 60 ft wide unopened and unimproved right-of-way known as Reams Road, containing approximately 0.297 acres will not operate to the detriment of Orange County or the public.
