- SUBJECT: March 21, 2017 Consent Agenda Item Cooperative Extension Division Employment Agreement

Cooperative Extension in Orange County is administered through, and supported by, the University of Florida in collaboration with Orange County Government. Pursuant to Florida Statutes Section 1004.37(3), recommendations for Extension positions are to be presented for acceptance by the Board of County Commissioners.

The University has conducted a search and recommends JanaFaye Griffin as the new Orange County Extension Agent I, Family and Consumer Sciences. Ms. Griffin will be filling an existing and budgeted vacant position. The funding for this is split between the County (40%) and the University of Florida (60%) in accordance with the existing agreement between the County and the University for this program.

Ms. Griffin will be responsible for providing leadership for the development, implementation and evaluation of Family and Consumer Sciences programs in Orange County in collaboration with a team of County Faculty, UF Specialists and local citizen advisors. Ms. Griffin will also work closely with other community organizations and government entities to provide more sustainable health and wellness practices to the citizens of Orange County which will reduce long term health care costs.

Ms. Griffin has a Bachelor of Science degree in Kinesiology and Exercise Science from Florida State University and has been a nutrition educator since 2004. A copy of the job description and Ms. Griffin's resume, along with the position letter from the University of Florida are attached. Ms. Griffin's anticipated start date is March 27, 2017.

# **Position summary**

University of Florida/IFAS Extension and Orange County seek to fill a 12-month, permanent status-accruing Family and Consumer Sciences Extension Agent position with specialties in health, nutrition and wellness, with a focus on using exercise science concepts to lower short and long term health risks. The agent will 1) provide leadership for planning, implementing, evaluating, and reporting on a comprehensive education program in the areas of health, nutrition and wellness; 2) work with UF/IFAS state extension specialists to implement the ServSafe Food Managers and Handlers training and certification and to implement and help coordinate the Family Nutrition Program grant in the county; 3) conduct programs educating target populations and organizations on the positive health effects of proper nutritional choices and physical activity.

The agent will be expected to have the ability to work with the latest program delivery methods including social media and other innovations such as the use of fitness trackers as part of evaluation. The candidate will network with other agencies and groups on cooperative educational programs and will form an advisory committee to assess clientele needs and program direction. The candidate will work closely with Central Extension District colleagues, the County Extension Director, and the District Extension Director, and will assume other duties as assigned by the Directors to meet the responsibilities of the total county extension effort. The agent will create an annual plan of work and report of accomplishment and will submit all required faculty reports. It is expected that the candidate will have excellent organizational skills, good record-keeping techniques and will be able to respond to clients in a timely and efficient manner. The agent will be expected to attain promotion and permanent status per state extension faculty guidelines.

Additional qualities of the successful candidate include:

- A working knowledge of social media and marketing, Facebook, video conferencing, and other similar educational techniques.
- Ability to work with other extension agents as part of a team.
- Ability to write articles and fact sheets; develop multi-media presentations; create posters and exhibits.
- Ability to acquire program enhancement grants, develop collaborations with healthcare providers, and seek extramural funding.

- Ability to develop or assist with 4-H Youth Development activities.
- Participation in professional organizations appropriate for this position.

# Qualifications

A bachelor's degree in Sport and Exercise Science or a related field is required. If hired with a bachelor's degree only, at least 50% progress towards obtaining a master's degree is expected within 6 years of employment. Experience in teaching, writing, and developing educational programs is preferred. Demonstrated abilities in organizational skills and written and oral communication are necessary. The agent must be personable and have an astute ability to build strong collaborations with internal and external partners. The candidate must be willing to work irregular hours and weekends. Occasional overnight travel is required. Must be able to obtain a Florida driver's license and be willing to travel using personal transportation. Within 6 months of hire, the agent must obtain the American College of Sports Medicine Certified Personal Trainer (CPT) certification and the ServSafe Food Managers and Handlers certification.

#### **Special requirements**

The successful candidate must pass background and drug free workplace tests required by Orange County. The policies established by Orange County government in administering leave shall apply to extension faculty.

I am pleased to offer you the positions of Orange County Extension Agent I, Family and Consumer Science, position #0001-4183, beginning Monday, March 27, 2017. The salary will be \$47,696.00 with a 40%/60% split in funding source between Orange County, \$19,078.40/40% and the University of Florida, \$28,617.60/60%. Please note your employment is contingent upon your passing the county's prescreening process and approval of the Orange County Board of County Commissioners. This offer is also contingent on a successful pre-employment screening, which includes a review of criminal records, reference checks, and verification of education by the University of Florida.

As an Extension Agent I, Family and Consumer Sciences, you will work under the direction of Dr. Richard Tyson, Orange County Extension Director, (CED) and Dr. Tim Momol, the Central District Extension Director (DED). As with all County Extension Faculty your plan of work, report of accomplishments, and annual performance reviews will be under the supervision of the Central District Extension Director.

Your appointment is subject to the constitution and laws of the State of Florida and the rules and regulations of the Board of Trustees of the University of Florida.

Special conditions of your employment:

- If you propose to engage in any outside activity or have a potential conflict of interest, you shall notify your supervisor in writing (using the proper University of Florida forms) prior to engaging in these activities. Such notification must be done annually (effective July 1 for future academic years) for as long as you continue to engage in such activity or have such conflict of interest.
- There is also considerable travel with evening and weekend meetings, which may or may not be by personal vehicle.
