South Florida Water Management District Local Government -

Grant Agreement Amendment 4600003023-A3 (Lake Down

Sub-basin 9 Stormwater Project)

The Environmental Protection Division is requesting approval of the South Florida Water Management District (SFWMD) Local Government - Grant Agreement No. 4600003023-A3 (Lake Down Sub-basin 9 Stormwater Project - \$115,000 for engineering design and construction). The matching funding for this project will come from the Windermere Water and Navigation Control District (Windermere MSTU).

This Grant Agreement was originally entered into on June 2, 2014 and is between the SFWMD and Orange County. It is a cost-share agreement for funding of stormwater improvements on Lake Down. These improvements were expansion and improvement of swales, wetland restoration and stormwater pond upgrades.

Amendment A-1 of the Agreement was entered into on May 28, 2015. This Amendment replaced the proposed improvements of the original Agreement with the construction of a nutrient separating baffle box and weir repair. It also extended the Agreement to June 2, 2016. Amendment A-2 limited the stormwater improvement to construction of the nutrient separating baffle box and extended the Agreement to February 17, 2017. Amendment A-3 will extend the Agreement 120 days to June 17, 2017 for invoice submittal and payment purposes.

This AMENDMENT NO. 3, is entered into on MAR 0 7 2017, to that AGREEMENT dated June 2, 2014, and as amended on May 28, 2015 and June 21, 2016, between "the Parties," the South Florida Water Management District (DISTRICT), and Orange County (COUNTY).

### **WITNESSETH THAT:**

WHEREAS, the Parties entered into an **AGREEMENT** wherein the **DISTRICT** would provide financial assistance to the **COUNTY** to construct stormwater systems to reduce pollutant loadings within Lakes Down and Tibet; and

WHEREAS, the **AGREEMENT** may be amended with the prior written approval of the Parties; and

WHEREAS, **AMENDMENT 1** revised the Statement of Work, revised the Payment and Deliverable Schedule and extended the period of performance; and

WHEREAS, AMENDMENT 2 further revised the Statement of Work and extended the period of performance; and

WHEREAS, the Parties wish to further amend the **AGREEMENT** in order to extend the period of performance to allow for invoice submittal and payment;

NOW THEREFORE, the **DISTRICT** and the **COUNTY**, in consideration of the mutual benefits flowing from each to the other, do hereby agree as follows:



# SOUTH FLORIDA WATER MANAGEMENT DISTRICT AMENDMENT

- 1. The term of the **AGREEMENT** is hereby extended by 120 days and the expiration date, as amended, is June 17, 2017. This **AMENDMENT NO. 3** shall be effective upon the date of execution by the Parties.
- 2. This **AMENDMENT NO**. 3 shall be at no additional cost to the **DISTRICT**
- 3. All other terms and conditions of the **AGREEMENT** remain unchanged.
