2:00 P.M. PETITION TO VACATE – PTV-16-03-011 – ISABEL N. GALAGARZA - DISTRICT 4

The petitioner requests that Orange County vacate a portion of a 30 ft wide unopened and unimproved right-of-way known as Trigonía Street, containing approximately 0.17 acres. The petitioner wishes to vacate in order to add the unused right-of-way to her parcel. This public hearing was continued at the February 21, 2017 Board of County Commissioners' meeting.

PETITION TO VACATE – PTV-16-11-028 – CHRISTOPHER WRENN, ON BEHALF OF D.R. HORTON, INC. – DISTRICT 1

The petitioner requests that Orange County vacate a portion of a 30 ft wide unopened and unimproved road right-of-way, containing approximately 0.46 acres, and a portion of a 33 ft wide unopened and unimproved right-of-way, containing approximately 0.16 acres, for a total of approximately 0.62 acres. The right-of-way petitioned to be vacated is located adjacent to Avalon Road (CR 545) which is planned to be widened in the future. The County will retain an easement over the right-of-way to be vacated until such time it is no longer needed by the County. The petitioner wishes to vacate in order to incorporate the unused right-of-way into their property to allow for future development.

Reason For Vacation

The petitioner requests that Orange County vacate a portion of a 30 ft wide unopened and unimproved right-of-way known as W South Street, containing approximately 0.213 acres. The petitioner owns the parcels abutting the portion of right-of-way requested for vacation and wishes to vacate in order to join the two parcels.

Location of Property/Legal Description

The property lies south of Old Winter Garden Road and east of S Kirkman Road. Public interest was created per the plat of Sun-Kist Park, as recorded in Plat Book "P", Page 27, of the Public Records of Orange County, Florida. The parcel addresses are 5139 and 5200 W South Street and they lie in District 6.

Statement of No Objection

The Real Estate Management, Engineering, Transportation Planning, Roads and Drainage and Environmental Protection Divisions have consented to the request. All utility providers have also consented. The Relationship Disclosure and Specific Expenditure forms have been submitted.

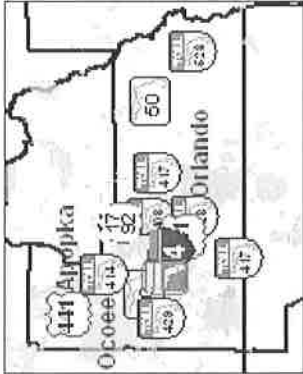
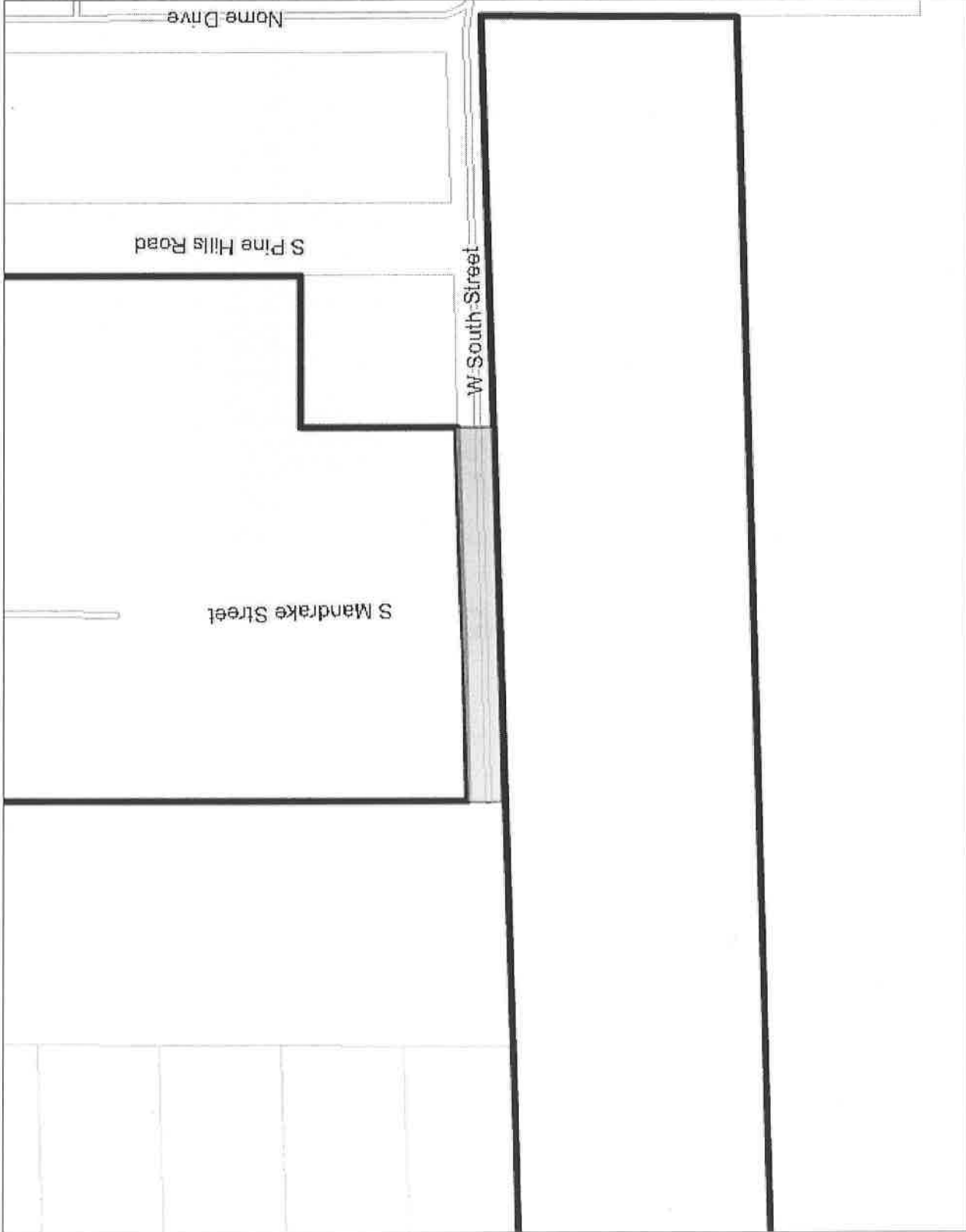
Staff Findings
