April 2017 Neighborhood Pride Sign Grant Recipients

The Neighborhood Preservation and Revitalization Division administers the Neighborhood Pride Grant Program that provides funds for citizen organizations to enhance the quality of their neighborhoods. The Neighborhood Pride Grants are available countywide in amounts ranging between \$1,500 to \$10,000. Neighborhood Pride Grant applications are accepted year-round and are reviewed monthly by the Neighborhood Grants Advisory Board (NGAB).

The NGAB is recommending the approval of two Sign Grants: Fairview Shores Neighborhood and Arbor Ridge West II Neighborhood (see Attachment A). The grant requests are displayed in greater detail in Attachments B and C. The grant requests were reviewed and scored by Orange County staff and presented to the NGAB for recommendation. The applications were reviewed based on project feasibility, organizational readiness, and benefit to the community. In addition, the applications were reviewed against the County's permitting requirements to ensure that the projects would comply with appropriate County codes. This project does not require a match.

ACTION REQUESTED: Approval of April 2017 Neighborhood Pride Sign Grants as recommended by the Neighborhood Grants Advisory Board for Fairview Shores Neighborhood (\$5,000) and Arbor Ridge West II Neighborhood (\$5,000). Districts 2 and 5.

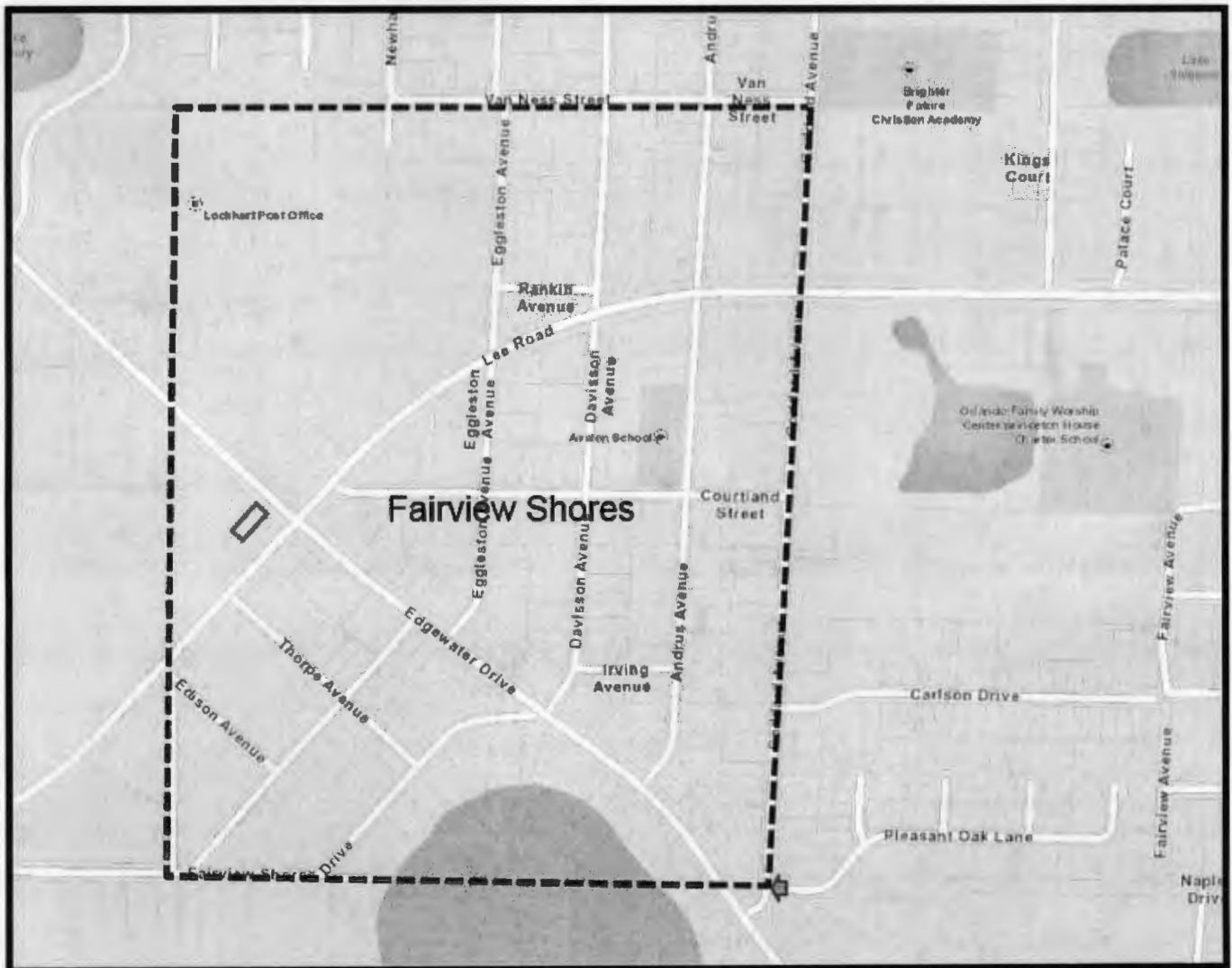
