SUBJECT: Transfer of EMS Equipment purchased with the State of Florida EMS Trust Fund  
**Consent Agenda – April 11, 2017**

Each year the State of Florida awards the Orange County EMS Office of the Medical Director funds from the state EMS Trust Fund. The funds are derived from a surcharge that is added on to traffic tickets. Each county is awarded a share of the surcharge based on the number of tickets written in the previous year. Over the last couple of years, the funds awarded to Orange County have averaged approximately \$180,000. The funds are used to purchase equipment and supplies for local EMS and nonprofit agencies that enhance the County EMS system operation.

In order to transfer ownership of the equipment and remove the equipment off the county's inventory, Board approval is required. The transferred equipment will be used by the recipient agency for its useful life.

**ACTION REQUESTED:** Approval to transfer equipment purchased with the State of Florida EMS Trust Fund and remove it from the EMS Office of the Medical Director inventory. **(EMS Office of the Medical Director)**
