





Design Techniques

- Manage Size Reduction with the following:
 - Parking structures
 - Joint-Use facilities
 - Co-locate schools
 - Off-site storm water
 - Underground exfiltration (on-site)
 - Multi-Story buildings (auditoriums and gyms excluded)
- ***** If options not available lot areas to be increased by 10%



Signage (EMC)

- Ground Sign (Prohibited as wall sign)
- Maximum Height 8' (Copy Area 32 Square Ft.)
- Advertise school functions only
- Sleep mode required
- Limited next to residential uses

Charter Schools

- Section 1002.33, Florida Statutes: "Beginning July 1,2011, a local governing authority must treat charter schools equitably in comparison to similar requirements, restrictions, and processes imposed upon public schools that are not charter schools."
- Charter Schools are public schools by definition
- Charter schools are not included in current regulations.

Additional Changes:

- **Bike Walk Central Florida**
 - Roundabout option
 - High Schools may be allowed on local or collector roads if site has access to multiple streets to distribute traffic
- **OCPS**
 - Recommended 5 year re-evaluation of the school siting ordinance
