

ORDINANCE NO. 2017-_____

AN ORDINANCE IN ORANGE COUNTY, FLORIDA,
PERTAINING TO AIR QUALITY AND AIR POLLUTION
CONTROL; AMENDING SECTION 15-90, ADOPTION OF
STATE AND FEDERAL RULES BY REFERENCE;
PROVIDING FOR LIBERAL CONSTRUCTION;
PROVIDING FOR INCLUSION INTO THE CODE; AND
PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Environmental Protection Commission ("EPC") was created by the Orange County Air and Water Pollution Control Act, Chapter 67-1830 (the "special act"), and exists under the Orange County Charter; and

WHEREAS, the EPC is authorized, subject to Orange County's approval, to establish an air pollution control program in Orange County ("County") pursuant to chapter 67-1830, Laws of Florida (1967); and

WHEREAS, in 1971, the EPC, pursuant to its authority conferred by special act, adopted pollution control rules approved by the Board of County Commissioners and which were subsequently incorporated into Division 2 of Chapter 15, Article III of the Orange County Code; and

WHEREAS, on April 3, 1989, the Florida Department of Environmental Regulation, now Department of Environmental Protection (hereinafter "DEP"), and the County entered into a general operating agreement relating to air pollution control; and

WHEREAS, DEP administers several U.S. Environmental Protection Agency ("EPA") - approved or EPA-delegated air pollution control programs; and

WHEREAS, in 2016, DEP and the County entered into a Specific Operating Agreement ("SOA") authorizing the County to act on behalf of DEP in matters relating to air pollution control; and

WHEREAS, the SOA sets forth the terms and conditions under which the County will implement air program management, permitting, compliance and enforcement responsibilities, ambient air monitoring, and data management; and

44 WHEREAS, the SOA contemplates that from time to time, the County will consider
46 measures to keep the County's air quality and air pollution control programs and standards
consistent with DEP's programs and standards.

50 **Section 1. Amendments; In General.** Throughout this ordinance, additions to the
Orange County Code are shown by underline, and deletions are shown by strike-through.

52 **Section 2. Amendment of Section 15-90.** Orange County Code Section 15-90
("Adoption of State and Federal Rules by Reference") is hereby amended as follows:

56 (a) The board of county commissioners hereby adopts
58 by specific reference thereto the rules of the DEP relating to air
quality standards and criteria, design, construction, permitting,
60 performance, operation, maintenance, monitoring, and reporting
requirements for air pollution sources, as they exist as of

(b) The board of county commissioners hereby adopts by specific reference the regulations of the EPA as set forth in 40 ~~CFR-CRF~~, Subpart M, for asbestos ("NESHAP") as they exist as of ~~December May-1, 2016-2014~~.

Section 3. Liberal Construction. The provisions of this ordinance shall be liberally construed to effectuate its purposes.

Section 4. Inclusion in the Code. It is the intention of the Board hereby provided that the provisions of this ordinance shall be made a part of the Orange County Code; that the sections of this ordinance may be renumbered or relettered to accomplish such intention; and that the word "ordinance" may be changed to "section," "article," or other appropriate designation.

Section 5. Effective Date. This ordinance shall take effect pursuant to general law.
