SUBJECT: Award of Invitation for Bids Y17-191-MG, Inmate Apparel and Bedding-Term Contract

ACTION REQUESTED:

Approval to award Invitation for Bids Y17-191-MG, Inmate Apparel and Bedding – Term Contract, to the low responsive and responsible bidder per lot, for 1-year term contracts (see below). Further request authorization for the Procurement Division to renew the contracts for four additional 1-year terms.

Bob Barker Company, Inc. for Lots 1, 2, 4, 5, 6, 7, 8, 9, 11, and 12 in the estimated contract award amount of \$309,197.50.

Tabb Textile Co., Inc. for Lot 10 in the estimated contract award amount of \$132,022.

PROCUREMENT:

This contract will provide inmate apparel and bedding on an as-needed basis. Purchases may include inmate uniforms, under garments, sheets, blankets, mattresses, mattress covers and towels.

FUNDING

Funding is available in account: 0001-081-3835-4115

APPROVALS:

The Corrections Department and the Business Development Division concur with this recommendation.

REMARKS:

Eleven bids were received in response to the Invitation for Bids. The bids were evaluated for price, responsiveness and responsibility. Uniform Manufacturing Inc. is determined to be non-responsive for Lot 6 because their bid submitted for

lines 40-43 deviated from the required units of measure. HR Cotton USA, Carolina Textiles and Dana Safety Supply were deemed non-responsive for all lots because their bids was not submitted on the revised bid form issued through Addendum 2. Staff performed a technical evaluation of the bids and determined that each low bid was reasonable based on market research and experience. The bids of Bob Barker Company, Inc. and Tabb Textile Co., Inc. have been determined to be the low responsive and responsible bidders for the lots listed and are recommended for award. Therefore, award is recommended to Bob Barker Company, Inc. for Lots 1, 2, 4, 5, 6, 7, 8, 9, 11 and 12, and Tabb Textile Co., Inc. for Lot 10. Lot 3 was awarded within Procurement's authority.
