Approval to award Invitation for Bids Y17-734-PH, Tealwood Cove, Lakewood Forest, and Tuckaway Terrace Water and Wastewater Improvements Package 7 to the low responsive and responsible bidder, Metro Equipment Service, Inc., for the estimated contract award amount of \$1,889,495.

#### PROCUREMENT:

The improvements include the construction of 5,335 linear feet of 4, 6, and 8-inch water main and appurtenances. The installation of cured-in-place-pipe lining of 5,400 linear feet of existing 8-inch sanitary sewer main and road restoration is also included. This project is located in District 2.

Funding is available in account numbers 4420-038-1503-6310 and 20-038-1448-6340.

The Business Development Division evaluated the 3 lowest bids of the 4 bids submitted for this project and found that the apparent low bidder Metro Equipment Service, Inc. did not achieve good faith effort documentation and reported 8.34% MWBE participation in their bid. Please note the following certified MWBE participation:

Mbe-hm	EM Pacing Company	\$82,000
Total MWBF	E Participation	\$157,500.00 (8.34%)

The second low bid submitted by Maxwell Contracting, Inc. did not achieve good faith effort documentation and reported 4.69% MWBE participation in their bid.

The third low bid submitted by Cathcart Construction Company-Florida, LLC did not achieve good faith effort documentation and reported 3.47% MWBE participation in their bid.

None of the bids were within the MWBE sliding scale range to be awarded this contract over the low bidder.

Our evaluation of these bids was based on the participation listed on the subcontractor/supplier page. If the low bidder is not chosen, please let us know so that we may obtain Letters of Intent to confirm the participation.

Attached is a spreadsheet reconciling the bidders' compliance with the IFB's M/WBE requirements, including the percentage breakdown for all bidders and a comparison of the relative bids versus participation percentages.
