WHEREAS, Central Floridians would be better served if the local toll roads were owned and operated by our local toll agency to address the needs of our community, workforce and visitors; and

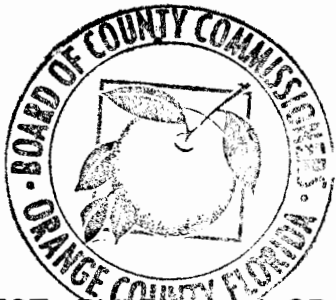
WHEREAS, the CFX Governing Board has expressed an interest in purchasing the local toll roads within its jurisdiction.
