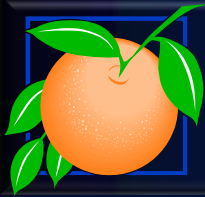

# Background

**On Nov. 29, 2016, the BCC reviewed CFHLA's proposal to amend Chapter 4 of the Orange County Code to extend the hours of operation for sale and consumption of alcoholic beverages in various places including hotels, motels and restaurants.**



# Current Regulations

## Section 4-3 of Orange County Code:

- **Permits on premise sale and consumption of alcoholic beverages from 11 a.m.- 2 a.m. of following day**
- **Exceptions:**
  - **Golf course may serve 7 a.m. to sundown**
  - **Private function at banquet hall or convention facility with minimum 10,000 sq.ft. may serve 7 a.m.-3 a.m.**
  - **Hotel and motel may serve 7 a.m. – 3 a.m. at private hotel guest rooms**



# Surrounding Communities

| Osceola  | 7 a.m.-2 a.m., except<br>Sunday 11 a.m.-2 a.m. | Very similar to OC. Golf course<br>and hotel room hours to 7<br>a.m.- 2 a.m. Sunday only |
| Seminole | 8 a.m.-2 a.m., except<br>Sunday 11 a.m.-2 a.m. | None   |

| Apopka        | 9 a.m.-12 a.m., except Sunday 12 p.m.-12 a.m. | Jan 1, 12 a.m.-3 a.m.   |
| Ocoee         | 11 a.m.-2 a.m.                                | None  |
| Orlando       | 7 a.m.-2 a.m., except Sunday 9 a.m.-2 a.m.    | Exempts airports and City venues from hourly limitations;<br>Dec. 31 <sup>st</sup> 7 a.m.-3 a.m.  |
| Winter Garden | 7 a.m.-2 a.m.,<br>Restaurants 11 a.m.-2 a.m.  | Dec.31 <sup>st</sup> 7 a.m.-3 a.m.  |
| Winter Park   | 7 a.m.-11 p.m., except Sunday 11 a.m.-11 p.m. | Dec. 31 <sup>st</sup> 7 a.m.-1 a.m.;<br>Westside Community 11 p.m.<br>Sun-Thur. & 12 a.m. Fri-Sat |



# CFHLA Proposal

## Key Changes Proposed to 11 a.m. – 2 a.m. Hours in Section 4-3:

- Amend subsection (a)(3) to allow sale and consumption of alcoholic beverages at any place inside a hotel or motel from 7 a.m. – 2 a.m. and continue to allow sale and service at private guest rooms until 3 a.m.
- Add subsection (a)(4) to allow sale and consumption at food service establishments from 7 a.m. – 2 a.m.



# **Board Action Requested**

- **Approval and execution of an Ordinance of Orange County, Florida pertaining to Alcoholic Beverages; Amending Section 4-3 of the Orange County Code relating to Hours of Sale and Consumption of Alcoholic Beverages; and Providing an Effective Date. All Districts**
